I wish to register my opposition to the proposed zoning change which I feel would result in a building that would be entirely out of character with the surrounding neighbourhood and could set a dangerous precedent in the already-threatened community of Strathcona. I live within a block of the proposed rezoning site and I walk around this neighbourhood very frequently. I often note the incongruity of the Adanac Towers, at the corner of Adanac and Commercial, which looms over the entire area, dwarfing everything around it. I feel that the proposed addition to the Villa Cathay Care Home would have the same kind of jarring effect and would seriously damage the sense of architectural integrity that currently characterizes Strathcona. The proposed structure would be approximately three times as tall as any other structure in the area. I cannot believe that the only way the Care Home can add new beds is to stick a huge tower in one corner of the lot. Surely significant density increases can be achieved by spreading the growth across the entire footprint of the property rather than creating an anomalous, incongruous 11 storey tower that uses less than 50% of the footprint. Please do not grant the proposed rezoning.
