Dear Michelle McGuire,

Due to prior commitments we were unable to attend the short community open house for 7249 Cypress St., April 17th. That notwithstanding, we wish to voice our objection to the rezoning application of 7249 Cypress Street to CD-1 on the following points:

the development :

1. will substantially increase flow-through traffic in an already very busy, SEVEN point intersection. Exit from Cypress on to 57th, in either direction, with vehicles parked on both sides of Cypress and W 57th is already a challenge, requiring a vision of almost 270 degrees before ingress. Also, while school is in session (McKechnie Elementary, 7455 Maple St.), very few early graders walk, adding to the traffic flow-through at specific times. This development will only exacerbate traffic conditions. A serious accident is just waiting to happen.
2. will create higher demand for on-street parking. Cypress street between 57th and 54th is already subjected to transient vehicles both for church functions and for customer access to the commercial units on 57th. Increasingly Cypress residents find it difficult to park in front of their own residence without the addition of this development. Underground parking for the proposed row house residents will only serve to accommodate the residents - if they use them – and definitely not for their guests.
3. will create a situation that may only be the start of further purchasing and seeking rezoning of contiguous property, given that two lots north of the proposed development are also odd shaped and form the balance of the triangle.

Further, there is no indication to us of the specific proposed uses under which this CD-1 District might be permitted. CD-1 zoning can be a dog's breakfast.

The above points were raised in a letter to the developer after the first showing several months ago. In addition, the letter pointed out that the artist's rendition of the row houses was abysmal and not in keeping with the immediate community. No response – a minor point, but indicative of the developer's attitude.
