Dear Vancouver Mayor and Council,

As we previously stated in an e-mail to Heather Burpee, Planning and Development Services, dated June 5th, 2013, we would like to voice our opposition to the York Theatre's request to amend the city signage by-laws. While we do not feel that one fascia sign with permanent signage would be a problem, we feel that a projecting or electronic sign with changeable copy would be an eyesore and is ill-suited for this neighbourhood. Such high visibility signage would only benefit the York Theatre and would cause negative visual impact and light pollution in the area. As well, we do not feel that city-owned property is an appropriate place for corporate advertisements.

Unlike the blocks south of Vennables, this side of Commercial Drive is primarily residential. This is not a commuter passageway, nor is it a shopping or entertainment district, thus increased advertising is inappropriate. If the operators of the theatre wish to plug their sponsors, they are more than able to do so within the confines of the current city by-laws, as well as however they please inside the business itself.
