Dear Sirs/Madames,

I am writing to express my **strong support** for the proposed redevelopment of Point Grey Hospital. There are numerous reasons why the rezoning should go through but, I would like to emphasize a couple of key points with which I have direct experience:

-We need **more high quality long-term beds** on the westside of Vancouver. Not only would this allow more of our elderly to remain in their familiar communities, it will make it easier for their loved ones and friends to easily remain a part of their daily lives. I cannot stress how important this is to all involved.

I would suggest that those opposing this redevelopment have not had to commute on a daily basis up to 45 minutes each way to visit a friend or relative. I had to do so for several years (much to the detriment of my work and family- life), as there were no suitable LTC beds available anywhere close to where we lived. Fortunately, my Mother now resides back in her familiar neighbourhood at Point Grey Hospital, close to her family and friends. Visiting with her is now an easy part of our daily routine and not an expensive and time-consuming proposition. Furthermore, we are once again able to enjoy the nearby beach and park together as the paved pathways are ideal for wheelchairs.

-As a former resident of the 2400 block of Point Grey Road, I know that summer beach traffic and late-night revellers cause far more of a disturbance than the presence of the hospital ever could. From May through September our life was disrupted day and night. Hospital residents/visitors never blocked my driveway with their cars, littered at will, or threw beer bottles at my balcony. Point Grey Hospital is currently a very well maintained and quiet property that blends in well with the rest of the street (in fact, many people don't even realize that it is a long-term care facility!) and will remain so after redevelopment.

Now and in the future, our elderly are entitled to live out their years in their own familiar neighbourhoods and not be isolated far from the support of their loved ones. We should be maintaining family ties-not tearing them apart. Redeveloping Point Grey Hospital is another step toward making Vancouver a truly livable city for all. I urge the Council to have foresight and amend the Zoning By-Law to allow the redevelopment of Point Grey Hospital.
