SUBJECT: 2014 Community and Neighbourhood Arts Development Grant Allocations

## **RECOMMENDATION**

THAT Council approve a total of \$462,400 in Community and Neighbourhood Arts Development Grants to 64 organizations as listed in Appendix A. Source of funds to be the 2014 Cultural Grants Program budget.

## REPORT SUMMARY

This report recommends grant allocations totalling \$462,400 to 64 organizations which celebrate and promote the diversity of Vancouver's vibrant and creative communities and neighbourhoods, support artistic excellence and innovation, and increase opportunities for public participation and engagement in arts and culture.

## COUNCIL AUTHORITY/PREVIOUS DECISIONS

Approval of grant recommendations requires eight affirmative votes of Council.

## REPORT

# Background/Context

The Community and Neighbourhood Arts Development grants program is an evolution of the Celebration Grants program created in October 2002. The program provides cash grants to community-based festivals, neighbourhood celebrations and community-engaged arts and culture projects. The program also provides a service grant component providing an offset of up to 50% of the cost of City services (police and engineering) to a maximum of \$10,000 for large scale parades that do not have Civic status.

## PROGRAM DESCRIPTION AND OBJECTIVES

The City of Vancouver's vision for arts and culture is to support a diverse and thriving cultural ecology that enriches the lives of residents and visitors. This program supports projects which celebrate and promote Vancouver's unique communities and neighbourhoods through arts and cultural activities and artist and community collaborations ranging from amateur to professional practices. The program has the following objectives:

- To celebrate and promote the diversity of Vancouver's vibrant and creative communities and neighbourhoods
- To support artistic excellence and innovation
- To increase opportunities for public participation and engagement in arts and culture

## STRATEGIC ANALYSIS

The objectives of this program align with the updated Cultural Plan and in particular with two key strategic directions:

- Fostering Cultural Leadership (celebrate artistic excellence and expanding support to emerging, innovative and artistic practices);
- Increasing participation and engagement (promote local arts and culture and improve arts access for new and under-served communities).

In assessing the applications, the committee highlighted several projects which they considered to be meeting the criteria in a strong way:

Aboriginal Artists and Arts Organizations - To support artistic excellence and in the spirit of the Year of Reconciliation (to June 2014), the committee was enthusiastic in their support of initiatives which promote and support Aboriginal artists and celebrations in Vancouver. These include the *13 Cedar Bark Robe* project which will bring hand-made cedar robes worn by Aboriginal elders into various communities to increase dialogue and connection to their culture; support for an authentic Aboriginal Artisan program to raise awareness of authentic aboriginal artwork and build capacity for local artists; a series of Artists Residencies at the Native Education Centre to help individuals connect with their culture through access to artists and creative skills; and the National Aboriginal Day celebration on June 21<sup>st</sup>, at the Aboriginal Friendship Centre and Trout Lake.

Youth Engagement in Arts - To expand support to emerging artists and increase access to underserved communities, the committee was also supportive of several projects which empower youth in the arts. These include support to the Safe Amplification Society for their Space Camp workshops for youth to have access to safe and affordable music performance opportunities and venues; a program to provide access to the arts for at-risk youth in the Grandview-Woodlands neighbourhood through afterschool programs delivered by Arts Umbrella; Kids CHORFEST, a first time festival and gathering of children's choirs in Vancouver to sing together; and LOVE OUT LOUD, an arts celebration coordinated by youth of Leave Out Violence BC at the car-free day event on Main Street.

Community-Wide Celebrations - In support of promoting local arts and culture and increasing participation and engagement, the committee was highly supportive of many celebrations which cross boundaries through an art form or cultural celebration. These include:

- the 10<sup>th</sup> anniversary of the Diwali festival;
- the annual South Asian festival celebrating light;
- the 10<sup>th</sup> anniversary of the Vancouver International Bhangra Celebration bringing community together through the dance form of Bhangra;
- the Vancouver Chinatown Spring Festival and Parade which celebrates the annual Chinese lunar New Year;
- the 7<sup>th</sup> annual Accordion Noir festival which brings people together through music of the accordion;
- the annual Pride festival and market which takes place at the end of the parade and celebrates the LGBTTQ community;
- and the longstanding Renfrew Ravine Moon and Winter Solstice festivals which bring together thousands of people to celebrate the fall and winter solstice annually.

## ASSESSMENT CRITERIA AND PROCESS

## Criteria

To assess how well an application meets the program objectives as stated above, questions are posed with related criteria to determine the following: clarity of organizational mission, alignment of project goals with the mission, resources in place to support the project including key personnel, timelines, volunteers, venues, and funding, along with anticipated impact on participants and the general public. Responses are evaluated against 'best practice' criteria and those groups who rank higher in meeting the criteria, are most likely to be recommended for support.

# Online Application

Building on the City's Digital Strategy, staff extended the online pilot application process that was first launched through the Operating grants program in 2014, to this program. This change resulted in a paper-free process, streamlined administration and improved data gathering capability. Staff will review the results of a survey delivered to the online applicants to inform directions and changes to online processes in future.

## Assessment Committee

A call for nominations is made on an ongoing basis and qualified members of the arts and cultural community are encouraged and invited to be part of the Assessment Committees. Community members join Cultural Planners to form the committee. This approach has been successful in that it allows for practicing artists and administrators to contribute their current knowledge to the process, while allowing staff to impart a funding history and a thorough financial and organizational analysis of the applicant and overall knowledge of the sector. # Outreach and Capacity Building

In preparation for the March deadline, a general information session was held for over 100 potential applicants and four drop-in technical labs were hosted to support the transition to the online system. Staff also provided consultation with individual organizations as needed and met with the Assessment Committee members in advance of the meetings to provide general orientation to the program and online system.

As part of ongoing efforts in capacity building, Cultural Services partnered with the Park Board - Arts, Culture and Environment team and Emily Carr University of Art & Design - Culture and Community faculty, and delivered its second gathering of community artists and organizations to talk about the practice and to identify strategic directions for continued success.

Culture + Community: Social Practice and the City, was held on October 25 - 26, 2013 at Emily Carr University, as well Great Northern Way campus, and attracted over 100 participants over the two days.

Staff will continue to offer support for this grant program through information sessions, and workshops on topics which may include grant-writing, developing partnerships and building resources to ensure successful project outcomes.

## Organizations and Activity Statistics

Eighty-three applications were received, the largest intake to date for this grant program, for a total request of \$1,093,191. The breadth of the applicants and projects provide evidence that the program is reaching and supporting the diversity of Vancouver's vibrant and creative communities and neighbourhoods. Of the 64 being recommended for support, 52 groups identified as serving specific diverse communities as indicated in Table 2.

Based on a sample of statistics provided in an online final report from 2013 grant recipients of this program, the numbers are pointing to evidence that the program is supporting artistic excellence and innovation by assisting artists with the development of their work and activities, as well as increasing opportunities for public participation and engagement through numbers of participants and volunteers.

An early sample of key statistics indicates that in 2013 there were:

- 9,922 artists involved in creating 1,793 artistic works.
- 1,011 activities for the public to participate in
- total attendance 1,762,735,
- 4,663 volunteers were engaged.

This was the start of collecting statistics from this applicant group in a more robust way through the online survey application format. Staff will continue to gather these types of statistics to track and measure outcomes over time.

# Summary of Recommendations

The recommendations in this report reflect a thorough review of each application against assessment criteria. Not all organizations meet the criteria at the same level as their peers and therefore, in a competitive process with finite resources, not all requests are being recommended for support.

In assessing 83 applications, the committee noted the breadth and diversity of the community and the numerous opportunities for celebration in the city. The committee also noted that many good ideas were proposed but that some proposals may not have been fully developed or resourced to provide confidence they would be achieved. Staff will follow up with those organizations to provide context and assistance in putting forward stronger projects and applications in future.

The Assessment Committee is recommending support for 64 organizations. Please see Appendix A for a list of recommendations.

## Financial

Approval of \$462,400 in grants to 64 organizations represents the full allocation of the Community and Neighbourhood Arts Development grants portion of the 2014 Cultural Grants budget. The balance of the 2014 Cultural Grants budget will be considered by Council and allocated in a Theatre Rental Grants report in early summer and a report in the fall of this year supporting strategic directions in the Culture Plan and directions arising from recent input by Assessment Committee members engaged in the Operating and Projects grant applications review.

# Community and Neighbourhood Arts Development Program (CNAD)

### PROGRAM DESCRIPTION AND OBJECTIVES

The City of Vancouver's vision for arts and culture is to support a diverse and thriving cultural ecology that enriches the lives of residents and visitors. This program supports projects which celebrate and promote Vancouver's unique communities and neighbourhoods through arts and cultural activities and artist and community collaborations ranging from amateur to professional practices. The program has the following objectives:

- To celebrate and promote the diversity\* of Vancouver's vibrant and creative communities and neighbourhoods
- To support artistic excellence and innovation
- To increase opportunities for public participation and engagement in arts and culture

# **Eligible Applicants**

- City of Vancouver-based, not-for-profit societies, registered in BC and that have been
  operating for at least 6 months prior to application deadline. Projects need to take place
  within City of Vancouver.
- First Nations Band Councils located within the City of Vancouver are eligible to apply.

# Eligible projects and activity

Festivals and Celebrations with a strong arts or cultural theme, which are open and accessible to the public. Examples include ethno-cultural celebrations, significant cultural anniversaries, neighbourhood or community arts festivals in any creative discipline.

Major Parades that are one-day events with a significant artistic or cultural component (performances, costumes, floats, banners, arches and installations), with the ability to attract a large audience (over 10,000), have a budget of over \$15,000, and a minimum of 20 organizations participating. Major Parades which have not been designated as "Civic Parades" are also eligible to apply for a Service Grant of 50% of City services costs to a maximum of \$10,000.

Community Arts Development - initiatives that involve artist and community collaboration, active engagement and meaningful participation among the participants, with positive benefits to communities and neighbourhoods. Projects should have some form of public presentation or documentation to share knowledge.

Examples of projects may include:

- The creation of artwork in any media where the community is involved in its development.
- An Artist residency within a neighbourhood or community.
- · The development and implementation of neighbourhood or community art plan.
- Community Arts Services and Resources (workshops, conferences, research, and other learning opportunities for community arts)

Projects can be artist or community-led and should demonstrate strong partnerships between artists and community members.

Only one application and grant per applicant, per year. Repeat applications for projects (or phases thereof) can be considered only if previously funded projects or phases are completed and final reporting has been submitted and approved by the City.

## Ineligible projects and activities

- Organizations and activities eligible for or receiving funds through the City of Vancouver Operating or Project Cultural grants programs
- Projects where artistic or cultural activities are not central
- Sporting events, demonstrations, marches, and rallies
- · Core training or in-class education or curriculum-based activity
- · Marketing, promotional or commercially-oriented events
- Fundraising events
- Activity which has already taken place (retroactive)
- Deficit reduction
- Capital projects

## Use of Grant funds and Amounts

Programming: fees for artists\* and key creative or community contributors, artist and volunteer services, production/technical staff, venue and equipment fees, materials, permits, maintenance, site costs, evaluation and documentation.

Administration and Marketing: co-ordination, event or project management, fundraising, related office expenses, insurance, marketing, communication and social media

Under normal circumstances, the maximum grant is \$20,000. The level of grant will depend on the proposal's budget and scope and how well it aligns with program objectives and evaluation criteria. The total City of Vancouver contribution to a project will not exceed 50% of the proposed budget (this includes resources from all departments).

#### PROFESSIONAL DEVELOPMENT AND CAPACITY BUILDING LEARNING OPPORTUNITIES

The City of Vancouver offers additional assistance to access workshops and learning opportunities for leaders in the non-profit cultural community. #### ASSESSMENT

#### CRITERIA

Most questions in the Application Form have corresponding criteria displayed directly below the question. Criteria represent 'best practices' in the arts and culture sector. Organizations will be assessed on how best they meet the criteria according to the response or material they provide. It is not anticipated that organizations will meet the best practice in every criteria. Please read through the Application Form in advance to review all criteria.

#### MODEL

Cultural Services uses a blended assessment approach whereby members of the arts and cultural community (peers) are nominated to participate in the assessment process along with Cultural Planners from Cultural Services. This approach has been successful in that it allows for practicing artists and administrators to contribute their current and historical knowledge of a particular sector/form, while allowing staff to impart a funding history and a thorough financial and organizational analysis of the application and overall knowledge of the sector. Cultural Planners and Peer Assessment Committee members meet to discuss the submissions and make recommendations to City Council for consideration and approval.

## ASSESSMENT COMMITTEE PEER REVIEW

A call for nominations is made on an ongoing basis and qualified members of the arts and cultural community are invited to be part of the Assessment Committee. Members of the arts and cultural community are highly encouraged to participate in the assessment process. ## **CULTURAL PLANNER REVIEW**

Cultural Planners undertake a preliminary check to ensure the submission is complete. Please note that the online application will be reviewed by Assessment Committee members as submitted.

## RECOMMENDATIONS AND REPORT TO CITY COUNCIL

A report on the Assessment Committee recommendations is written by staff and submitted to City Council for consideration and approval. At the same time, applicants will receive a Recommendation Notification from Cultural Services, with the recommendation and amount along with comments from the Assessment Committee. The report is made public on the City's website shortly before the Council meeting date. Names of the Assessment Committee members are also made public in this report.

#### RESULTS

Once Council approves the report, notification letters are sent to all applicants indicating the result. Successful applicants will receive payment, by separate post, usually within three weeks of the Council meeting date. This entire application process as outlined above takes approximately five months from application deadline to receipt of the grant cheque or direct deposit.

## CONDITIONS OF ASSISTANCE

If your organization receives an Operating grant, the following conditions will apply:

- Grant funds must be applied to current expenses, not used to reduce or eliminate accumulated deficits. Activities cannot be funded retroactively.
- The Society will make every effort to secure funding from other sources as indicated in its
  application. It will keep proper books of accounts of all receipts and expenditures relating
  to its activities and, upon the City's request, make available for inspection by the City or its
  auditors all records and books of accounts.
- If there are any changes in the organization's activities as presented in its application,
  Cultural Services must be notified in writing of such changes immediately. In the event that
  the grant funds are not used for the organization's activities as described in the
  application, they are to be repaid to the City in full. If the activities are completed without
  requiring the full use of the City funds, the remaining City funds are also to be returned to
  the City.

- The City of Vancouver requires cultural organizations receiving a civic grant to
  appropriately acknowledge the City's support in all their information materials, including
  publications and programs related to funded activities. Such recognition must be
  commensurate with that given to other funding agencies. Grant recipients can contact

  receive the City's logo electronically.
- · Receipt of a grant does not guarantee funding in the following fiscal year.
- A final report must be submitted within 6 months upon completion of the project. No new applications will be considered until a final report has been submitted and approved by Staff.

## CONFIDENTIALITY

All documents submitted by Applicants to the City become the property of the City. The City will make every effort to maintain the confidentiality of each application and the information contained therein except to the extent necessary to communicate information to staff and peer assessment committee members for the purposes of evaluation and analysis. The City will not release any of this information to the public except as required under the Province of British Columbia Freedom of Information and Protection of Privacy Act or other legal disclosure process.
