I work in Vancouver in Property Management, and I am writing to support the Marine Gardens Rezoning Application.

At this time there is a low income rental housing shortage and since Marine Gardens cannot be retrofitted or rebuilt as is, the agreement with the developer to rebuild the 70 rental units is extremely important. In addition, because the developer will also build two daycare centers, this will benefit the community and will also replace the previous Marine Gardens daycare.

The developer is offering a very generous relocation allotment to each tenant who must move out. This is an unprecedented amount of money and I believe it will offer some valuable assistance to the current tenants who are also caught in the lack of rental units for low income families.
