
I am writing to support the proposed project for 445 Southwest Marine Dr. I believe the city has a great need for affordable housing and this project will help address the issue. For families, large and small, it is important the city be able to provide the option for individuals to be close to family and be independent. Through my discussions with members of the community, I have found that less available and affordable housing is overpowering the tradition of close family ties.

From my personal experience, I have recently had an uncle move to Delta because he could no longer afford to pay his mortgage and raise his 3 children. Despite our families collective efforts to help him, we were unable to see him stay. These types of distances put a strain on extended family because we are no longer in close proximity to offer help when it is needed. projects such as Marine Gardens will help families stay close to one another so that they can sustain those support networks.

The primary concern in a proposal such as this, is the displacement of current residents. No one should be asked to leave without being given adequate and reasonable assistance to relocate. After reviewing the proposal in depth, I am satisfied with the Developer's action plan to assist the current residents to find different housing. I have one suggestion however; I would request the a secondary 'moving cost' bursary be added to help with residents who wish to return to the new rental suites at Marine Gardens.
