1. REZONING: CD-1 Rezoning - 508 Helmcken Street

An application by GBL Architects Inc., on behalf of Brenhill Developments Ltd., was considered as follows:

Summary: To rezone 508 Helmcken Street from DD (Downtown) District to CD-1

(Comprehensive Development) District, to permit the development of a 36-storey mixed-use building with 448 residential units, of which 110 are secured market rental housing. Retail and a private pre-school/kindergarten space are at grade. An increase in height from 21.3 metres (70 feet) to 97.5 metres (320 feet) and an increase in floor space ratio (FSR) from 3.0 to 17.19 are proposed.

As a public benefit associated with this rezoning application, the applicant proposes to provide social housing at 1099 Richards Street, including replacement housing for the residents of Jubilee House presently located at 508 Helmcken Street. The site at 1099 Richards is currently going through a separate Development Permit application process.

The General Manager of Planning and Development Services recommends approval, subject to the conditions as set out in the Summary and Recommendation of the agenda.

Staff Opening Comments

The General Manager of Planning and Development Services, along with Planning and Development Services staff, reviewed the application and responded to questions.

Stu Lyon, GBL Architects, and Max Kerr and Laurie Schmidt, both from Brenhill Developments, were available to respond to questions.
