It is the right thing to do, especially given the *enormous* global pressures on Vancouver and our early neighbourhoods. Rampant demolition across the west side has turned established leafy, gardened neighbourhoods into strips of big box houses with big box garages. If it weren't for our mature street trees, much of the west side (especially south of West 41st) feels like new subdivisions in the suburbs. The very elements that made these neighbourhoods attractive in the first place -- well-built gracious houses surrounded by mature gardens - have been eradicated.

My mother lives in the house she was born in 83 years ago close to Van Dusen Gardens. Her neighbourhood is a wasteland of enormous empty houses built from cheap composite materials.

Weekly, real estate agents - often the same ones -- knock on her door and say she is too old to be living there and they have many prospective buyers who will pay cash and build new.

Every house on her block has been demolished. It is too late for much of the west side.

First Shaughnessy represents an important piece of Vancouver's early history. Its houses can take a great deal of pushing and pulling and renovating, but they need to stay.

As a city, we need to do a better job, especially for those new to our city, at creating and conveying the prestige and cachet of First Shaughnessy's magnificent old houses, built by hand out of our rain forests' First Growth firs.

Regardless of the development community's push for demolition(and they have done quite well enough in our current gold rush), designating First

Further to my presentation last week, I have been on the First Shaughnessy Design Panel for over 6 years, 3 as Chair. I am also the Representative for the HAP and a VP of SHPOA.

There are two key areas in the HCA that need to be considered by you.

1. Changes to the ODP. As I discussed the current ODP is not a good document. It is interpretative vs. factual and has allowed the development of very poor architecturally designed homes in order to maximize square footage on a lot. The new ODP Planning developed is a very good one and will solve many of the concerns the neighborhood has and will streamline the approval process. <u>This needs to be implemented immediately</u>. The new ODP should be reviewed in 2 years to ensure that it is a document that is executable and accomplishing what it was intended to do.

I do not support the grandfathering of current applications. The ones mentioned in the Public Hearing presentations are more of the same. Overbuilt, out of scale and the removal of mature landscaping. I urge you not to do this.

2. The List. As a member of the HAP we requested the list to include all heritage A, B, C and those homes with meritorious value and historical importance in the neighborhood. This was going to take some time and a lot of effort but is a well thought out approach. The sweeping statement of all pre 1940's homes on the list I believe is a not good idea and should not be the recommendation just because of time constraints. There are some homes that do not have historical importance and *those owners should not be penalized*. I suggest a readjustment of this list. There could be a variety of ways to accomplish this either through a committee of heritage experts, owners submitting their homes be removed from the list with a statement of significance or a combination of both within a time frame (6-8 mos). Or another approach. Extend the demolition ban and take the time and do it properly.

After a proper assessment is completed of the list, if an owner wants to tear down the house the proposed Public Hearing approach is fine.

My recommendation would be to pass the HCA with an amendment that included a thorough review of the protected list to ensure we have the best of the best and that owners are not penalized who shouldn't be. That is fair.

Thank you for your consideration and commitment to the neighborhood.

Dear Mayor and Councillors

Having addressed you on behalf of the Heritage Commission in favour of the proposed Heritage Conservation Area for First Shaughnessy, I 'm writing as a private resident of First Shaughnessy, someone lucky enough to be a fourth generation FSD resident and as someone familiar with most of the houses-interior as well as exterior in this historic mansion area. I was involved at the outset in 1982 with Joyce Catliffe, City Planner, and the President of the Shaughnessy Heights Property Owners Association who shepherded the Overall Development Plan through its public hearing.

First of all, I'm delighted that after 33 years the plan is being reconfigured as a Heritage Conservation Area to ensure that Vancouver does have a historic mansion area like any other beautiful city. I'm also pleased that the act makes the status of each property abundantly clear and accessible for future owners. The design guidelines have had their loopholes closed, and the landscape is again as every bit important as the house design/restorations, having been written with a view to the greening of the overall site. The view to the future to gently accommodate further density is fully supportable and very family friendly.

I wish I could be there for the rest of the public hearing, but I'm out of town. I wanted to also back up the letters of Lori Kozub Hodginson and Elizabeth Murphy - I think nearly all of their points are well taken. Perhaps the pre-1940 houses that are being disputed for their heritage value (such as Brian Hill's house which the First Shaughnessy Advisory Design Panel supported for demolition in the early '90's after a site visit), could be quickly evaluated on a case by case basis as we do for S.O.S. candidates without going through the entire list to save expense and time. Obviously if it is a Maclure, R.W. Fripp, or other notable architect, it's not coming down.

The most important part is the need for a review of the guidelines -in particular at the two year mark. As chair of the FSADP for 11 years, and a member of the Panel for the first two years, I've seen the Panel be consistent in their comments regarding the guidelines' shortcomings. Although there was supposed to be a review "from time to time", I've been worried that that might not include my lifetime! However, thanks to the earnest and capable work of staff and the consultant team we have a well thought out plan for the future.

I urge you to pass this legislation and extend my gratitude to those who support it.

Dear Mayor and Council,

Thank you for this opportunity to add to the comments I made on 21 July in **support** of the establishment of a Heritage Conservation Area in First Shaughnessy. During the public hearing I was asked two questions that I could not answer satisfactorily without additional research. I can provide a complete answer now.

In reference to my conversation with the City of Victoria Heritage Planning Department, **Councillor Carr** asked if property values had been affected there by the establishment of Heritage Conservation Areas. I spoke at length today with Victoria's Senior Heritage Planner Murray Miller. His overall summary of the situation: "What has been the general trend, if anything, is that property values have increased." He put this down to the "value placed on stability" as well as the "reasonable approach to infill and development" which occurs in HCAs. He also reported that "properties that have fetched the highest prices in Victoria are heritage designated properties." Mr. Murray has also worked in Edmonton where he was part of a study on the relationship between heritage designation and property values using a sample of 40 properties; the findings indicated "a clear increase in property values." He went on to say that there is "no evidence that would substantiate a downturn in property values, especially in residential areas." This fear that values will decline is "not informed" and is due to a lack of awareness of the potential of heritage Designation and Property Values: Is There An Effect which supports his viewpoint. Councillor Ball asked for my observations on Heritage Conservation Areas in other cities I've visited in recent years. Below is a list of the cities I travelled to in 2014 and 2015 and the requested information:

New York City, NY has 114 Historic Districts and 20 Historic District Extensions in all five boroughs. The total number of protected sites also includes 1,347 individual landmarks, 117 interior landmarks and 10 scenic landmarks.

Portland, OR has 15 Historic Districts, primarily located in or near the Central City. All of Portland's historic districts are listed in the National Register. Portland also has 6 Conservation Districts designated by the City of Portland.

Ottawa has 18 Heritage Conservation Districts. All of these districts are found within the urban area of the city.

Victoria has 10 Heritage Conservation Areas and an 11th in process. They are also researching citizen-initiated HCAs.

Toronto has 16 Heritage Conservation Districts.

Halifax has 1 Heritage Conservation District and 2 areas designated as National Historic Sites. Note that Halifax has such a concentration of registered buildings on the same street they seem to function as de facto Heritage Conservation Areas:

Edmonton has 3 proposed Heritage Areas.

Whitehorse is possibly too small for a Heritage Conservation Area; they have 17 protected buildings in their downtown core.

Montreal: Please see the attached email below.

I hope this information will help reassure you that, while some property owners in First Shaughnessy may be nervous about this change, it is unlikely to create financial hardship. To the contrary, it will enrich them as well as our city as a whole. So many North American cities (these are just the handful I happen to have visited recently) embrace Heritage Conservation Areas as a tool to save the best of the past -- for the future and for the community as a whole. Please support these recommendations.

Email from Heritage Montreal:

Montreal has a series of areas that are protected. In Quebec, our heritage is protected according to the Cultural Heritage Act and is under the authority of the Minister of Culture. The Act's Article 1 expressed to following objective.

«The object of this Act is to promote, in the public interest and from a sustainable development perspective, the knowledge, protection, enhancement and transmission of cultural heritage, which is a reflection of a society's identity. It is also intended to promote the designation of deceased persons of historical importance and historic events and sites. Cultural heritage consists of deceased persons of historical importance, historic events and sites, heritage documents, immovables, objects and sites, heritage cultural landscapes, and intangible heritage.»

See <u>http://www2.publicationsduquebec.gouv.qc.ca/dynamicSearch/telecharge.php?type</u> =5&file=2011C21A.PDF Quebec Cultural Heritage Act comprises a system of designation shared between the government and local administration like municipalities. These designations include the following ones which are more directly related to your issue

- "heritage site": a place, a group of immovables or, in the case of a heritage site referred to in section 58, a land area that is of interest for its archaeological, architectural, artistic, emblematic, ethnological, historical, identity, landscape, scientific, urbanistic or technological value;
- "protection area": an area surrounding a classified heritage immovable, defined by the Minister to protect the immovable.

For instance, in 1964, the Old Montreal was declared historic area (*arrondissement historique*). This would mean that anybody who wishes to:

- · Construct or demolish a building, in his entirety or partially;
- · Repair or modify the exterior of a building;
- Divide or subdivide of a lot;
- Replace or demolish a sign, board ...

Must obtain to authorisation from the Minister of Culture.

The Quebec Heritage Act is complemented by other pieces of legislation such as the Land Use and Development Act with enabling powers given to municipal and regional authorities to adopt, enforce or amend planning bylaws and masterplans. This Act also provides municipalities with the possibility to designate areas of their territory for their architectural and landscape interest and enforce special qualitative and design review processes with the support of local Planning Advisory Boards.

- In addition, the City of Montreal has its own Charter which is an Act of the Quebec Provincial Legislature which establishes a number of specific responsibilities and obligations including:
 - o Constituting the Conseil du patrimoine de Montréal (Montreal Heritage Council) actually, it was included in the Charter at the suggestion of Heritage Montreal.
 - o Constituting the Public Consultation Office to carry on public consultation on major projects, in particular those requiring changes to the City's Master Urban Plan.

Unfortunately, a lot of the information regarding the protection of our heritage is in French. I hope this will help you, even though our legislative system differ from yours in BC.
