I am writing to express my support for the proposed First Shaughnessy Heritage Conservation Area. I strongly believe that this policy is critical to modernizing Vancouver's heritage policy framework and preserving one of Vancouver's most prestigious neighbourhoods: First Shaughnessy.

Heritage Conservation Areas (HCA) are an effective, proven strategy for maintaining neighbourhood character while still supporting sensible densification. They have been successfull in over 70 locations in BC including ten neighbourhoods in Victoria. The policy has been demonstrated to incentivize the retention of older homes, limit demolitions (and consequent material waste) while allowing for the gentle density of infill, laneway and multiple conversion dwellings. This is densification done well that will maintain First Shaugnessy's historic Garden City-inspired landscaping while allowing new residents to enjoy the area's charms.

Existing policies such as "designating" heritage properties using a Heritage Revitilazation Agreement, while effective in some cases have been shown to be very complex when applied to individual houses with ordinary home owners. Similarly the Vancouver Heritage Register is effective at maintaining high-profile assets, but is too cumbersome to apply to broad swathes of a neighbourhood.

In contrast the HCA "schedules" meritorious properties based on the historic context of a neighbourhood which allows for the area to maintain its unique character. It also includes a City-controlled process for removing unmerited homes, including for demolition or rebuild. This policy respects the property rights of individual home owners while giving the City the tools (including a minimum maintenance bylaw) to maintain the look and feel of First Shaughnessy or other applicable neighbourhoods. It is much easier and has less risk to the City than using the existing tool box of heritage policies.

From an property value perspective the Corilois Consulting Report notes that:

"the proposed new regulations will not cause significant, persistent negative impacts on lot values for lots with pre-1940 houses in First Shaughnessy." (p.30, Economic Analysis of Proposed Changes to FSD: Supplemental Report, Coriolis Consulting Report July 2015). This clearly indicates that the proposed HCA policy will not have a significant financial impact on the neighbourhood, while having a very significant impact on the retention of First Shaughnessy's historic character (the whole reason many people buy homes there!).

Creating Vancouver's first Heritage Conservation Area in First Shaughnessy is a precedent setting moment for this City Council and will demonstrate a commitment to both neighbourhood character retention and heritage conservation to the citizens of Vancouver.

I view of the re-opened window on the topic of the establishment of a Heritage Conservation Area in First Shaughnessy, and as a former resident of Shaughnessy, I am writing to re-emphasize my support.

Municipalities across North America have policies and programs in place to protect heritage neighbourhoods and districts. British Columbia has 70 Heritage Conservation Areas, 10 of which are in Victoria, yet Vancouver has none.

First Shaughnessy is recognized as a unique architectural and historical area. Despite this, 56 of the 317 pre-1940 homes there have already been demolished. Only 11 are protected. In the 18 months before the June 2014 temporary moratorium on demolitions in the area, there were a further 19 inquiries to demolish. A Heritage Conservation Area will protect these homes.

A Heritage Conservation Area in First Shaughnessy will also have "city-wide applicability," meaning that other neighbourhoods, even certain blocks, could become Heritage Conservation Areas. A HCA is a much-needed tool for retaining our original, more sustainable and affordable housing stock, our green space, and our history.

I believe that there will be no long-term impact on housing values in a Heritage Conservation Area. As shown in other municipalities such as Sydney, Australia, value in heritage areas holds and grows due to the stability, beauty and desirability of these neighbourhoods.

In order to ensure that rezoning is fair and equitable to existing and future owners, the following permitted & prohibited uses would help to balance the economics to favour the heritage retention option. The rezoning should be amended now or as soon as possible after the moratorium deadline.

1. Allow all FSR in the retention option to be incorporated into the main house at the owner's discretion rather than having to build infill to maximize value. This could allow for a large single family house (which is what is currently preferred by the market), or for secondary suites, or for a multifamily conversion dwelling (MCD) which may or may not be stratified. This gives more options to the owner, including the option to use some of the FSR for infill if desired.

- 2. Exempt basements in FSR for the retention option only while including basements in FSR for the new construction option. This then becomes a bonus for retention.
- 3. Require full basements to be built in both retention and new construction options to reduce bulk of building massing. Require these to be suite ready, but optional for use to the owner's discretion.
- 4. Allow unlimited underground parking within the footprint of the building for the retention option only. This will be helpful if multiple units are provided and a benefit for owners in the retention option. This area should be exempt from FSR.
- 5. In order to make MCDs and infill more attractive for heritage and character buildings, the city should pressure senior governments to allow multiple units on one site of up to 3 or 4 units to qualify for the capital gains tax exemption for a principle residence as long as the owner lives in one of the units and the units remain non-strata.
- 6. Increase penalties for illegal demolition of character or heritage houses. Penalties could be considered a cost of doing business while imprisonment would be hard to enforce though proposed changes in the draft bylaws will help. However, penalties should be enforced through large reductions in FSR that are tied to the future land development so penalties cannot be avoided or mitigated through flipping the property for a change in ownership.

In summary, I urge you to accept the proposed recommendations and establish a Heritage Conservation Area in First Shaughnessy.

It is much easier to apply and lowers risk to the City compared with using the existing tool box of heritage policies.

From a property value perspective the Corilois Consulting Report notes that:

"the proposed new regulations will not cause significant, persistent negative impacts on lot values for lots with pre-1940 houses in First Shaughnessy." (p.30, Economic Analysis of Proposed Changes to FSD:

This clearly indicates that the proposed HCA policy will not have a significant financial impact on the neighbourhood, while having a very significant impact on the retention of First Shaughnessy's historic character (the whole reason many people buy homes there!).

Creating Vancouver's first Heritage Conservation Area in First Shaughnessy is a precedent setting moment for this City Council and will demonstrate a commitment to both neighbourhood character retention and heritage conservation to the citizens of Vancouver.

I wholeheartedly support the establishment of Heritage Conservation Area in First Shaughnessy.

Municipalities across North America have policies and programs in place to protect heritage neighbourhoods and districts. British Columbia has 70 Heritage Conservation Areas, 10 of which are in Victoria, yet Vancouver has none.

First Shaughnessy is recognized as a unique architectural and historical area. Despite this, 56 of the 317 pre-1940 homes there have already been demolished. Only 11 are protected. In the 18 months before the June 2014 temporary moratorium on demolitions in the area, there were a further 19 inquiries to demolish.

A Heritage Conservation Area will protect these homes.

A Heritage Conservation Area in First Shaughnessy will also have "city-wide applicability," meaning that other neighbourhoods, even certain blocks, could become Heritage Conservation Areas. A HCA is a much-needed tool for retaining our original, more sustainable and affordable housing stock, our green space, and our history.

I believe that there will be no significant long-term impact on housing values in a Heritage Conservation Area. As shown in other municipalities such as Sydney, Australia, value in heritage areas holds and grows due to the stability, beauty and desirability of these neighbourhoods.

I urge you to accept the proposed recommendations.
