SUBJECT: Naming of Street Extensions - Carolina Street and East 1st Avenue

RECOMMENDATION

- A. THAT the new public street extension west of Fraser Street running north from Great Northern Way, shown in heavy black outline on the graphic attached as Appendix A, be named as "Carolina Street".
- B. THAT the new public street extension north of Great Northern Way running west from the new extension of Carolina Street, shown in heavy black outline on the graphic attached as Appendix A, be named as "East 1st Avenue".
- C. THAT the Director of Legal Services be instructed to bring forward the appropriate amendments to the Street Name By-law.

CITY MANAGER'S COMMENTS

The City Manager submits the foregoing recommendations for consideration.

COUNCIL POLICY

Council uses the Street Name By-Law, No. 4054, to name and regulate public roads in the City of Vancouver. The Civic Asset Naming Committee was established by Council on February 29, 2012, and re-established on December 16, 2014. The Committee approves names to be added to the Names Reserve List based on input from staff regarding compliance with naming policies and guidelines and also recommends names to Council for new streets and roads, development areas, pedestrian and cycling infrastructure, and other City-owned assets and facilities (excluding Parks and Library assets).

PURPOSE

This report seeks Council approval of naming two new public streets located adjacent the Emily Carr University Great Northern Way Campus as "Carolina Street" and "East 1st Avenue", as they are extensions of the existing streets.

BACKGROUND AND DISCUSSION

At its meeting on November 3, 2014, the Civic Asset Naming Committee approved names for extensions of Carolina Street and East 1st Avenue. Carolina Street now extends north of Great Northern Way and the new east-west road intersecting Carolina aligns with East 1st Avenue to the west.

FINANCIAL IMPLICATIONS

There are no financial implications.

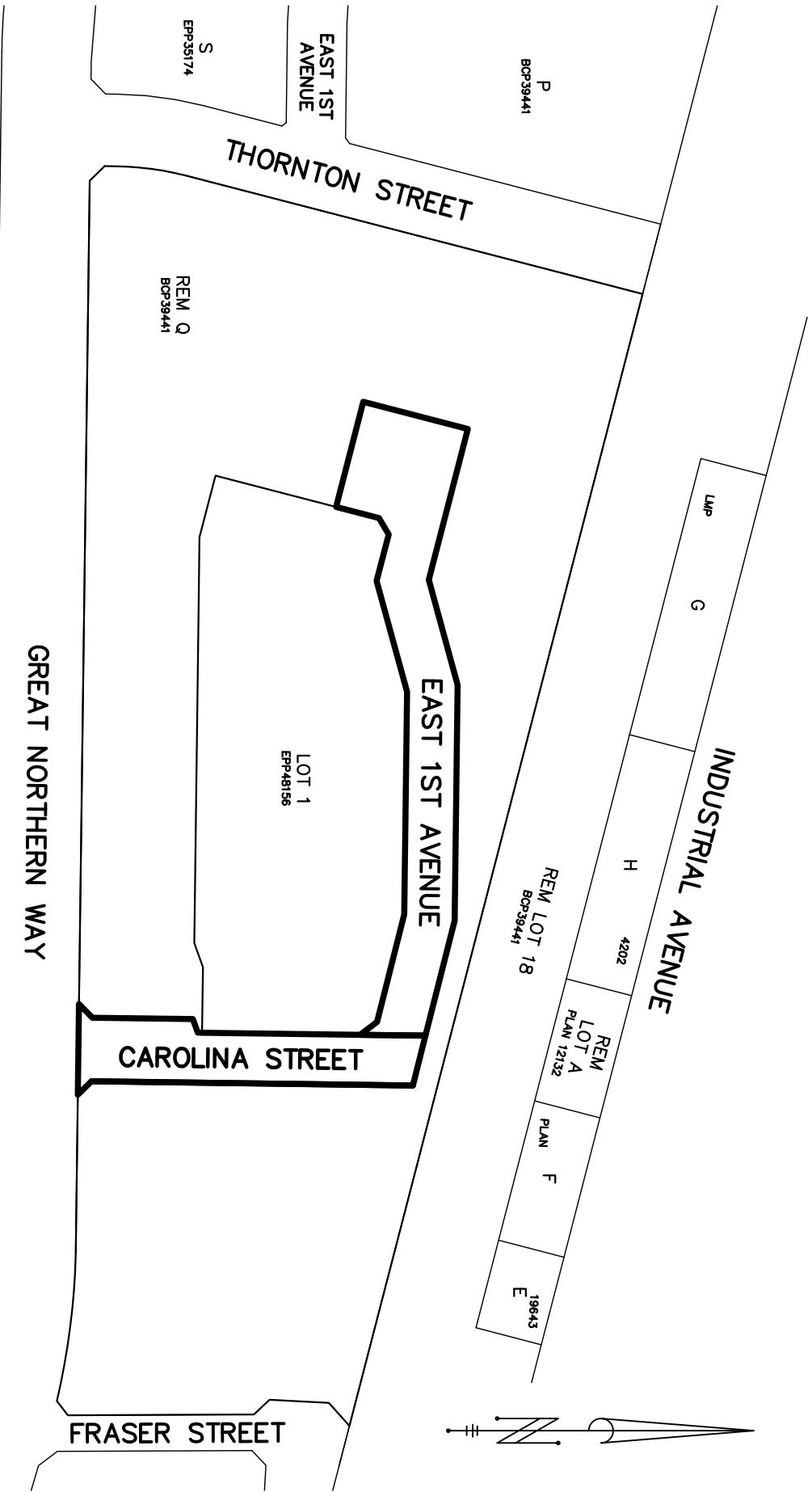
CONCLUSION
