1. Removal of the Georgia and Dunsmuir Viaducts October 6, 2015

At the Regular Council meeting on Tuesday, October 20, 2015, Council received a presentation regarding the Removal of the Georgia and Dunsmuir Viaducts, and referred the matter to the Standing Committee on City Finance and Services meeting on Wednesday, October 21, 2015, to hear from speakers.

On October 21 and 27, 2015, Planning and Development Services and Engineering Services staff responded to questions from Council.

On October 21 and 27, 2015, the Committee heard from 48 speakers. Twenty-one speakers expressed general support for removal of the viaducts. Nine of the speakers requested that Council use the viaducts removal as an opportunity to recognize Hogan's Alley and Black history in the city. Twenty-six of the speakers were generally opposed to the removal of the viaducts. Many of these speakers expressed concerns regarding Prior Street becoming an arterial or about the traffic impacts on Cottonwood Community Gardens. Two speakers spoke about other matters related to the report.

THAT the Committee recommend to Council

- A. THAT Council approve the removal of the Georgia and Dunsmuir Viaducts, and approve the *Northeast False Creek Conceptual Plan* (generally as presented in Appendix A of the Policy Report dated October 6, 2015, entitled "Removal of the Georgia and Dunsmuir Viaducts"), to guide area planning without the viaducts for the remaining areas of the False Creek North Official Development Plan and two City blocks east of Quebec Street.
- B. THAT Council direct staff to proceed immediately on planning for the new mixed-use neighbourhood including a road network in place of the viaducts with landowners and interested citizens, generally in accordance with the Northeast False Creek Conceptual Plan and the Northeast False Creek: Directions for the Future (2009);

FURTHER THAT Council direct that removal of the viaducts will not commence until such time as staff report back within 18 months or less on the necessary amendments to the False Creek North Official Development Plan, and other associated By-laws and Policies, a revised Public Benefits Strategy and associated funding strategy;

AND FURTHER THAT staff report back within 90 days on terms of reference for an expanded, renewed East False Creek Stewardship Group, to be appointed by Council, replacing the Northeast False Creek Joint Working Group, to provide advice and input during subsequent planning phases of the project, in addition to regular engagement strategies.

- C. THAT Council direct staff to work with the Vancouver Park Board and interested citizens on planning for new waterfront parks and open space of no less than 13.75 acres as well as options for expedited delivery of the new parks and open space, generally in accordance with the *Northeast False Creek Conceptual Plan* and the *Northeast False Creek: Directions for the Future (2009)*, and report back with the necessary amendments to the False Creek North Official Development Plan and other associated By-laws and Policies within 18 months or less.
- D. THAT Council direct the General Manager of Real Estate and Facilities Management and Director of Legal Services to negotiate and enter into, subject to Council approval, the necessary legal agreements and take such additional actions to implement the *Northeast False Creek Conceptual Plan* including the replacement street network, land exchanges and transfers, contaminated soils management, parcel re-configurations, and adjustments to the legal boundaries of Andy Livingstone Park.
- E. THAT Council direct the Director of Planning to prepare an application to rezone the lands adjacent to BC Place in area 10C in the False Creek North Official Development Plan (FCNODP) to increase the density and height permitted for the site to accommodate residential and non-residential use, on certain conditions, including the condition that BC Pavilion Corporation ("PAVCO") will enter into all rights of way and other legal agreements necessary to accommodate the new Georgia Street ramp alignment and integration with the mixed-use building and parkade.
- F. THAT Council advise One West Holdings Ltd. and related corporate entities ("Concord Pacific") that Council is willing to consider an application to rezone its lands in and adjacent to sub area 6C in the False Creek North Official Development Plan (FCNODP), to increase the density and height permitted to accommodate residential and non-residential use, on certain conditions, including the condition that the rezoning application complies with the proposed or enacted FCNODP amendments arising from the planning process, and that the rezoning results in the delivery of part or all of the new waterfront park (Creekside Park Extension) on an expedited basis.
- G. THAT Council direct staff to work with the Province on parcel reconfigurations, including the reconfiguration of the proposed Creekside Park Extension, environmental remediation matters, reconfiguration of the legal boundaries of Andy Livingstone Park and such other matters which are required to implement the Northeast False Creek Conceptual Plan.

H. THAT Council approve the downgrading of Prior Street to a local-serving street upon the completion of a new east/west arterial alignment to be determined through the False Creek Flats planning process;

FURTHER THAT Council direct the General Manager of Engineering Services to continue to pursue near-term improvements along Prior Street to continue to address community concerns about traffic-related safety.

- I. THAT the passage of B through G above, and approvals are subject to:
 - i. Completion of the work and reporting back to Council which is required or contemplated above, all to be to the satisfaction of Council;
 - ii. Conclusion of all agreements and other arrangements which are required for the replacement street network, land exchanges and transfers, parcel re-configurations, including the reconfiguration of the proposed Creekside Park Extension, and adjustments to the legal boundaries of Andy Livingstone Park, all to the satisfaction of Council; and
 - iii. Passage of all amendments to City of Vancouver by-laws which are required to facilitate those works in the Northeast False Creek Conceptual Plan as contemplated by the foregoing resolutions and approved by Council.
- J. THAT the passage of B through G above and consideration of matters set out in the Policy Report dated October 6, 2015, entitled "Removal of the Georgia and Dunsmuir Viaducts", will not fetter Council's discretion in considering any future rezoning applications or by-law amendments, including amendments to the False Creek North Official Development Plan, nor fetter the discretion of other City officials in discharging their duties nor will passage of the above resolutions create any legal rights for any person or obligation on the part of the City and any expenditure of funds or incurring of costs is at the sole risk of the person making the expenditure or incurring the cost.
- K. THAT Council approve a budget of up to \$21 million for the 2-year work program (2016-2017 as set out in Appendix B of the Policy Report dated October 6, 2015, entitled "Removal of the Georgia and Dunsmuir Viaducts"); sources of funding to be reported back as part of the 2016 Capital Budget;

FURTHER THAT the Director of Finance report back on the final project budget and a viable funding strategy upon completion of B through G above.

3. Taxi Service Review and Report Back October 13, 2015

At the Regular Council meeting on Tuesday, October 20, 2015, Council received a presentation regarding the Taxi Service Review and Report Back, and referred the matter to the reconvened Standing Committee on City Finance and Services meeting on Thursday, October 29, 2015, to hear from speakers.

Licences and Inspections staff responded to questions from Council.

Subsequently, the Committee heard from 26 speakers. Eleven speakers expressed concerns regarding issuing additional licences during peak times and allowing suburban taxi companies to do business in Vancouver. Eight speakers expressed concerns or offered suggestions about improving vehicle for hire safety and services, including services for passengers with disabilities or special needs. Seven speakers spoke in support of increasing ridesharing opportunities in the city, and three spoke in opposition.

THAT the Committee recommend to Council

- A. THAT Council receive the Policy Report dated October 13, 2015, entitled "Taxi Service Review and Report Back", with an update on recent consultations with the Vancouver Taxi Roundtable and other key stakeholders on the delivery of taxi service in the city (coined the Vehicle for Hire Dialogues), thank the participants for their contributions, and urge the Ministry of Transportation, the Passenger Transportation Board, YVR, the taxi industry, TransLink and other stakeholders to take steps to establish a renewed regional policy direction in the province that balances the needs of travellers with the requirement for a stable, sustainable taxi service in the context of new technology.
- B. THAT Council approve the following amendments to the *Vehicles for Hire By-law* and directions to staff:

Safety, First Aid & Customer Service

B1 Require taxi drivers to assist passengers with entering the taxi and loading/unloading their belongings.

Accessible Taxi Supply

B2 Support the VTA to appeal to the PTB to review their 2014 decision and approve 58 additional accessible taxis and change licence conditions for all 78 to remove the "one-for-one" replacement requirement.

B3 Require accessible taxi drivers to:

- i) wait at least five minutes for the passenger to arrive at the pickup point;
- ii) accompany passenger as needed (e.g. provide "door to door" service);
- iii) carry passenger's items to door; and,
- iv) in the event of medical emergency, wait for paramedics to arrive.

B4 Prepare a region-wide, long term strategy for accessible taxi supply (see broader discussion of a regional taxi model in B14 below).

Downtown Entertainment District

B5 Extend the temporary moratorium on new taxi licences for 12 months.

Enforcement

B6 Increase enforcement levels by:

- immediately commence regular enforcement actions to identify and issue fines to taxi drivers operating in Vancouver without a licence or in violation of their licence conditions and report findings back to Council; and,
- send a letter to the Passenger Transportation Branch, Ministry of Transportation & Infrastructure, requesting that they conduct additional concerted enforcement against taxis that operate in violation of their licence conditions.

B7 Increase the fines (from \$250 to \$500) for taxis operating without a licence (S. 7(1) of the Vehicles for Hire Bylaw) or in violation of their locational or temporal conditions.

Advanced Data Monitoring

B8 Investigate and liaise with the taxi industry, PTB, Ministry of Transportation & Infrastructure and other regulators in the region, and report back with a plan to implement a taxi data monitoring system, including necessary bylaw amendments and estimated budget.

Environmental Performance

- B9 Examine options for phasing in requirements for limousines to meet a minimum environmental performance standard for fuel efficiency.
- B10 Examine options to enable taxi sharing for certain trips (as per Action M 6.1.4 in the Transportation 2040 Plan).
- B11 Examine how taxi policy can support the integration of the Compass Card system with taxis (as per Action T 6.2.4 in the Transportation 2040 Plan).

Regional-level Taxi Planning

- B12 In liaison with the Vehicle for Hire industry, key users, other Metro Vancouver municipalities and the PTB, examine options for developing a regional context for informing planning, integration and regulation of the sector, including licensing implications.
- B13 Work with participants in the Vehicle for Hire Dialogue to develop a funding platform to enable them to continue the work of the process that is underway and come back to Council with a full scope, timing and funding partners.

Ridesharing

B14 Call on the Minister of Transportation and Infrastructure, working in liaison with other local governments in the region, the PTB, ICBC, the taxi industry and other key user stakeholder groups (e.g. disabled community, seniors, the Port and tourism), to participate in further roundtable process to examine the issues and opportunities for rideshare in Metro Vancouver with a view of establishing an appropriate policy framework before approving any ridesharing services in the province.

Housekeeping Updates

- B15 Increase the fee for a replacement plate to \$34.
- B16 Enable taxi licence fees to be paid on a pro-rated basis.
- C. THAT the Director of Legal Services be requested, should the Director deem it advisable, to bring forward by-law amendments generally in accordance with Council direction arising from the Policy Report dated October 13, 2015, entitled "Taxi Service Review and Report Back".

THAT Council receive the Policy Report dated October 13, 2015, entitled "Taxi Service Review and Report Back", with an update on recent consultations with the Vancouver Taxi Roundtable and other key stakeholders on the delivery of taxi service in the city (coined the Vehicle for Hire Dialogues), thank the participants for their contributions, and urge the Ministry of Transportation, the Passenger Transportation Board, YVR, the taxi industry, TransLink and other stakeholders to take steps to establish a renewed regional policy direction in the province that balances the needs of travellers with the requirement for a stable, sustainable taxi service in the context of new technology.
- B. THAT staff report back on the appropriate action to remedy the shortage of accessible taxis in Vancouver, and to ensure that service quality and wait times for accessible taxis are equivalent to those for non-accessible taxis.
- C. THAT Council approve the following amendments to the *Vehicles for Hire By-law* and directions to staff:

Safety, First Aid & Customer Service

- C1 Require taxi drivers to assist passengers with entering the taxi and loading/unloading their belongings.
- C2 As a condition of licensing, require all taxi drivers to pass a training program such as Ask-Listen-Act or equivalent, that teaches skills for transporting disabled passengers to ensure their safety and comfort.

Accessible Taxi Supply

- C3 THAT Council strongly support the VTA efforts to obtain approval for the 58 VTA wheelchair-accessible taxi licences in Vancouver and change licence conditions for all 78 to remove the "one-for-one" replacement requirement.
- C4 Require accessible taxi drivers to:
 - i) wait at least five minutes for the passenger to arrive at the pickup point;
 - ii) accompany passenger as needed (e.g. provide "door to door" service);
 - iii) carry passenger's items to door; and,
 - iv) in the event of medical emergency, wait for paramedics to arrive.
- C5 Prepare a region-wide, long term strategy for accessible taxi supply (see broader discussion of a regional taxi model in C13 below).

Downtown Entertainment District

C6 Extend the temporary moratorium on new taxi licences for 12 months.

Enforcement

- C7 Increase enforcement levels by:
 - immediately commencing regular enforcement actions to identify and issue fines to taxi drivers operating in Vancouver without a licence or in violation of their licence conditions and report findings back to Council; and,
 - sending a letter to the Passenger Transportation Branch, Ministry of Transportation & Infrastructure, requesting that they conduct additional concerted enforcement against taxis that operate in violation of their licence conditions.

C8 Increase the fines (from \$250 to \$500) for taxis operating without a licence (S. 7(1) of the Vehicles for Hire Bylaw) or in violation of their locational or temporal conditions.

Advanced Data Monitoring

C9 Investigate and liaise with the taxi industry, PTB, Ministry of Transportation & Infrastructure and other regulators in the region, and report back with a plan to implement a taxi data monitoring system, including necessary bylaw amendments and estimated budget.

Environmental Performance

- C10 Examine options for phasing in requirements for limousines to meet a minimum environmental performance standard for fuel efficiency.
- C11 Examine options to enable taxi sharing for certain trips (as per Action M 6.1.4 in the Transportation 2040 Plan).
- C12 Examine how taxi policy can support the integration of the Compass Card system with taxis (as per Action T 6.2.4 in the Transportation 2040 Plan).

Regional-level Taxi Planning

C13 In liaison with the Vehicle for Hire industry, key users, other Metro Vancouver municipalities and the PTB, examine options for developing a regional context for informing planning, integration and regulation of the sector, including licensing implications.

C14 Work with participants in the Vehicle for Hire Dialogue to develop a funding platform to enable them to continue the work of the process that is underway and come back to Council with a full scope, timing and funding partners.

Ridesharing

C15 Call on the Minister of Transportation and Infrastructure, working in liaison with other local governments in the region, the PTB, ICBC, the taxi industry and other key user stakeholder groups (e.g. disabled community, seniors, the Port and tourism), to participate in further roundtable process to examine the issues and opportunities for rideshare in Metro Vancouver with a view of establishing an appropriate policy framework before approving any ridesharing services in the province.

Housekeeping Updates

- C16 Increase the fee for a replacement plate to \$34.
- C17 Enable taxi licence fees to be paid on a pro-rated basis.
- D. THAT the Director of Legal Services be requested, should the Director deem it advisable, to bring forward by-law amendments generally in accordance with Council direction arising from the Policy Report dated October 13, 2015, entitled "Taxi Service Review and Report Back".
