To whom it may concern,

I usually don't participate in these types of discussions, but there have been some posters popping up in my neighbourhood lately that I think are worth addressing.

On the posters is a list of reasons why we should oppose the new development on 18th and Commercial, but I disagree. Vancouver is in the middle of a housing crisis. Homes need to be built. That's it.

This is more important than the number of parking spaces available on the street. Without an increase in supply of rental homes, young people will continue to be forced to move out of the communities they love and contribute to.

I love living in East Vancouver. On weekends, I volunteer my time to coach U5 field hockey, helping the children in my neighbourhood learn the value of team work and physical activity through sport. I rent a garden box on 12th and Commercial, hit up the Trout Lake Farmers market on Saturday and support local business on the Drive when I can. But in the two years since I've moved into my \$1,124/month, 450 square foot bachelor apartment at The Porter, the cost of rent for comparable apartments has gone up 16%. That's 4 times higher than the rate of inflation since my move in date.

Thankfully my boyfriend moved in last July because, as a student, I'm not sure I would be able to live in the city on my own. I'm also thankful that we like each other, because 450 square feet can sometimes be a bit tight for two people.

I find the opposition to developments like this really frustrating. What I hear is that if you aren't lucky or wealthy enough to own a home in East Vancouver, we don't want you here. We don't want you taking away our parking spots. We don't want too many of you coming here and taking away from 'the feel of the neighbourhood.'

Vancouver is a growing city, and with that comes growing pains. An increase in housing supply is needed to help the people who feel like they are being forced out of the communities that they know, love and contribute to, just because they don't have the capital to stay. Developments like this are needed if East Van is to remain the colourful, diverse and thriving community it is today.
