On behalf of the Board of the Health and Home Care Society of BC (Care BC) I am writing in support of the recommendation by Vancouver's General Manager of Planning, Urban Design and Sustainability "THAT the application by Colliers International on behalf of The Fair Haven United Church Homes, the registered owners, to rezone 2720 East 48th Avenue PID: 009-361-332; Lot 3, Block 11, North East ¼ of District Lot 336, Plan 10606], from CD-1 (Comprehensive Development) District (7A) By-law No. 3869 to a new CD-1 (Comprehensive Development) District, to increase the floor space ratio (FSR) from 1.03 to 1.55 FSR and the building height from 10.0 m (33 ft.) to 14.5 m (48 ft.) to permit a social housing development including 137 dwelling units, generally as presented in Appendix A of the Policy Report dated November 13, 2016 entitled "CD-1 Rezoning: 2720 East 48th Avenue" be approved".

Care BC has been operating the Family Respite Centre (FRC), situated on the ground level, south side, of the Vancouver Fair Haven building owned by The Fair Haven United Church Homes (Fair Haven) since September 2002. The FRC is located at 2711 East 49<sup>th</sup> Street, Vancouver, adjacent to Fair Haven's existing 50 units of affordable seniors' rental housing.

Care BC remunerates Fair Haven one dollar annually to occupy approximately 10,000 square feet of space to operate the FRC's Adult Day and Overnight Respite Program. In addition, the FRC has a contract with Fair Haven for food, laundry, housekeeping and maintenance services. This "partnership" attests to Fair Haven's long tradition of helping and supporting those in need in the community. The FRC exists primarily to support caregivers living within

Vancouver, by providing them with a "short break" from the 24/7 responsibilities of caring for a loved one with chronic health conditions, including dementia, so they may continue to look after that person at home rather than having to place them in long term care. Care BC's approach is consistent with Fair Haven's philosophy of offering local residents the opportunity to age in place.

Over the past 15 years that Care BC has received this generous support from Fair Haven, their Board and staff have proven to be caring, considerate "partners", always willing to be of assistance, and responsive to any issues that were identified. And there have never been concerns with the tenants living within the existing 50 rental apartments. For 50 years now, Care BC has also operated the Meals on Wheels (MOW) program in Vancouver. From time-to-time, the program receives referrals for hot meals and a brief visit from the MOW volunteers to provide support to seniors living within Fair Haven's housing units.

Since 2000, Care BC has also operated the Community Integration Project which includes two apartments at St. George's Place in Vancouver, where transitional housing and rehabilitative support are provided to individuals (including seniors) recovering from recently acquired disabilities. The greatest challenge has been finding affordable rental housing in Vancouver.

For these reasons, Care BC is in support of Fair Haven's application to the City of Vancouver to substantially increase the supply of affordable seniors' housing rental. It is not anticipated that the proposed redevelopment will in any ways negatively impact the ongoing operation of the FRC. Rather, the existing, aging structure on the site will be replaced with a safe, modern building and the supply of affordable rental housing options for low income seniors will be expanded in response to the growing community need.
