This letter is in support of the rezoning at the Dunbar Ryerson United Church. This is a much needed development in an area that has been mostly static for a long time.

Those who oppose this development say that this project will cause construction noise, additional traffic, tighter parking, and shadowing. They are absolutely right, and yet this building should nevertheless be built. Of course, the architects and developers must do their best to mitigate these impacts. However, living in a city, especially in proximity to transit and amenities means sharing space with your neighbours, for better or worse. This is something we must all deal with as Vancouverites.

Another criticism is that these units will not be affordable. This is also true. How could they be? Forcing the majority of new buildings in the city to go through a process like this basically guarantees unaffordability. This particular development has been doing the gauntlet for well over a year for just 72 units. I've personally spent many hours debating its merits at the open house and drafting letters to Council, and so have many others - time that none of us will get back. Restrictive zoning combined with a high-cost and high-risk rezoning process breeds speculation, consolidates the development industry to the larger players who can bear the risk, and creates an artificial shortage of land available for development. How do we expect to build the 10s of thousands of units that this city desperately needs?

Please approve this development. Furthermore, please formulate a plan to allow by-right development of apartments everywhere in the city so that we can all spend less time writing letters like this and more time with our friends and family in homes we can afford.

This email is about Dunbar Ryerson United Church, which I support.

The proposed project adds much needed housing that fits a large variety of family and income types, from social housing, to rental housing and strata condos, located in a great neighbourhood.

Relating to my situation, this is the kind of project I was looking for when I bought a condo for my family 6 years ago, a newer condo building on a quiet street in proximity to great amenities and in cycling distance to UBC where my wife works. We could not find projects like this within the City of Vancouver and settled at UBC instead.

I noticed that my name was explicitly mentioned in one of the letters submitted in opposition to the project, pointing to my census data maps showing that median household income in Vancouver is \$79,930.
