3. 2017 Cultural Grant Allocation to Assist Emerging Individual Artists September 20, 2017

THAT the Committee recommend to Council

THAT Council approve the disbursement of a grant of \$50,000 to ArtStarts in Schools to deliver the third year of the Independent Arts and Culture Fund (Creative Spark Vancouver) to support emerging individual artists. Source of funds is the 2017 Cultural Grants Budget.

4. Vancouver Civic Theatres Rental Rates 2018-2019 August 17, 2017

THAT the Committee recommend to Council

THAT Council approve the rental rates, as outlined in the Schedule of Rental Rates for Vancouver Civic Theatres (VCT) (Appendix A of the Administrative Report dated August 17, 2017, entitled "Vancouver Civic Theatres Rental Rates 2018-2019"), effective September 1, 2018.

5. Cultural Services - 1265 Howe Street Artist Studios Cultural Amenity - Tenant Selection and Lease Terms
August 20, 2017

THAT the Committee recommend to Council

- A. THAT Council approve 221A Artist Run Centre Society ("221A") as the not-for-profit tenant (the "Tenant") of the future City-owned air space parcel at 1265 Howe Street, Vancouver, which will contain approximately 10,872 square feet of artist production space, and currently legally described as: Parcel Identifier 029-098-041; Lot K Block 101 District Lot 541 Group 1 New Westminster District Plan EPP30416 (the "Premises").
- B. THAT Council authorize the Director of Real Estate Services, upon the City obtaining ownership of the Premises, to negotiate and execute a lease (the "Lease") with 221A Artist Run Centre Society as set out in the basic lease terms

attached as Appendix A of the Administrative Report dated August 20, 2017, entitled "Cultural Services - 1265 Howe Street Artist Studios Cultural Amenity - Tenant Selection and Lease Terms". The Lease is to be based on the City's Precedent Lease For Non-Profit Entities (Nominal Rent), drawn to the satisfaction of the Director of Real Estate Services, the Director of Legal Services and the Managing Director of Cultural Services.

As the rent under the Lease for the Premises will be below the applicable market rate and includes rent-in-lieu of property taxes, B above constitutes a grant valued at approximately \$271,800 per annum based on the first year of the term and requires an affirmative vote of two-thirds of all Council members, per *Vancouver Charter* S. 206(1).

C. THAT no legal rights or obligations will arise or be created by Council's adoption of A or B above unless and until all legal documentation has been executed and delivered by the respective parties.

ADOPTED ON CONSENT AND B BY THE REQUIRED MAJORITY (Vote No. 02262) (Councillors Ball, Louie and Mayor Robertson absent for the vote)

6. Hodson Manor Lease Recommendation - 1254 West 7th Avenue September 19, 2017

THAT the Committee recommend to Council

A. THAT Council authorize the Director of Real Estate Services to negotiate and execute a lease (the "Lease") with the Vancouver Society for Early Music (the "Society"), at a nominal rent and as set out in the basic lease terms attached as Appendix A of the Administrative Report dated September 19, 2017, entitled "Hodson Manor Lease Recommendation - 1254 West 7th Avenue", for the following City-owned premises (the "Premises"):

Hodson Manor located at 1254 West 7th Avenue and legally described as:

Parcel Identifier: 015-206-025; Lot A (Explanatory Plan 9418) Block 313 District Lot 526 Plan 590.

The Lease is to be based on the City's Precedent Lease for Non-Profit Entities (Nominal Rent), drawn to the satisfaction of the Director of Real Estate Services, the Director of Legal Services and the Managing Director of Cultural Services.

As the rent under the Lease for the Premises will be below the applicable market rate and includes rent-in-lieu of property taxes, A above constitutes a grant valued at approximately \$120,840 per annum for Hodson Manor based on the first year of the term, and requires an affirmative vote of two-thirds of all Council members, per section 206(1) *Vancouver Charter*.

B. THAT no legal rights or obligations will arise or be created by Council's adoption of A above unless and until all legal documentation has been executed and delivered by the respective parties.

7. Vancouver Community Sport Hosting Grants - Fall 2017 Intake September 25, 2017

THAT the Committee recommend to Council

- A. THAT Council approve twelve (12) new Community Sport Hosting Grants totalling \$83,500 as outlined in the Administrative Report dated September 25, 2017, entitled "Vancouver Community Sport Hosting Grants Fall 2017 Intake".
- B. THAT the grant be subject to each grant recipient agreeing to the terms and conditions of the community sport hosting grant program as generally outlined in this report and otherwise satisfactory to the Senior Manager, Sport Hosting and the City Solicitor.
- C. THAT the grants be funded from the 2017 Vancouver Community Sport Hosting Grant Program Budget.
- D. THAT no legal rights or obligations are created by the approval of A through C above unless and until the grant agreement letter is executive and delivered by the grant recipient.

ADOPTED ON CONSENT AND A AND B BY THE REQUIRED MAJORITY (Vote No. 02264) (Councillors Ball, Louie and Mayor Robertson absent for the vote)

8. Contract Award for 10th Avenue Health Precinct Street Improvements October 10, 2017

THAT the Committee recommend to Council

A. THAT Council authorizes City staff to enter into a contract with BA Blacktop, for Phase 1 of the 10th Avenue Health Precinct Street Improvements, with a contract value of up to \$2,502,517.49, plus applicable taxes, to be executed in two construction phases. Phase 1A (Southside) for \$1,534,132.41 is to be commenced in 2017 with an optional Phase 1B (Northside) for \$968,385.08, subject to the approval of the City Engineer in 2018 in accordance with the contract and subject to 2018 multi-year capital budget approval. Funding for Phase 1A is available from the current approved multi-year capital project budget for Active Transportation Corridors.

- B. THAT the Director of Legal Services, Chief Purchasing Official and General Manager of Real Estate and Facilities Management be authorized to execute on behalf of the City the contract contemplated by A above.
- C. THAT no legal rights or obligations will be created by Council's adoption of A and B above unless and until such contract is executed by the authorized signatories of the City.
