I am writing this letter in support of the rezoning application for York House School, 4176 Alexandra Street. This application is scheduled for a public hearing at City Hall on Tuesday, January 16, 2018.

I am a teacher at York House School as well as a former parent. Our daughter attended this school from Kindergarten to Grade 12 (1995-2008).

Our family was first drawn to this school because of its focus on providing a progressive education for girls of all ages and having the heart of a strong caring community. I have since become an educator at this school because of its continued focus on excellence in educating girls and its strong community spirit. I work with colleagues who are dedicated to delivering an educational experience that equips girls to be innovative leaders of this rapidly changing world.

We have developed a comprehensive strategic plan to help us develop the road map for us to continue to offer excellent academic, co-curricular and athletic programs for future generations. We have the plan, and we have the dedicated staff eager to pursue the educational opportunities of the present and future. In order to fulfill our ambitious plans, we need to redevelop our existing facilities.

Current programs such as, physical education, are limited due to our inadequate facilities. We simply do not have the space to deliver all of our physical education programs within the hours of a typical school day. Consequently, our ability to be nimble in our programming and scheduling of other academic programs is impacted. We are also unable to fully develop innovative programs as we do not have the space within the current facilities. For example, as outlined in the new BC curriculum, project-based learning encourages students to find innovative solutions for real-life problems. These programs require spaces not only to deliver academic programs, but also areas where students can collaborate, design, build and experiment. Providing these programs will allow girls to not only see their dreams come into fruition, but it will also build upon their confidence to solve tomorrow's challenges. Currently, due to the limitations of our facilities and enrollment, we are only able to partially offer some of these programs, but the need is much greater than what we should provide.

The future is unknown to us. However, the potential of our youth is known to us- and it is great. It is our duty to provide them with the tools that will allow them to reach their potential, and thereby build a stronger community for all of us.
