REPORT SUMMARY

This report recommends appointments to the Urban Design Panel and the First Shaughnessy Advisory Design Panel.

COUNCIL AUTHORITY/PREVIOUS DECISIONS

On December 11, 2003, City Council approved selection criteria for appointments to civic agencies, and the establishment of a Nomination Subcommittee of Councillors to screen applications in accordance with those criteria. On January 13, 2004, City Council approved the selection process for making appointments.

On December 8, 2014, Councillors Elizabeth Ball, Andrea Reimer and Tim Stevenson were appointed to the Subcommittee.

On April 6, 2016, City Council approved a policy that requires the number of women appointed to City advisory committees to be equal or greater than 50%.

REPORT

Background/Context

The recommendations contained in this report will fill current vacancies which occurred due to terms ending.

The Architectural Institute of British Columbia put forward an additional nominee for Council's consideration in order to achieve gender balance on the Urban Design Panel. If the recommendation in this report is approved, the panel will meet the gender balance policy with six men and six women appointed.

The First Shaughnessy Advisory Design Panel currently has seven female members, if the recommendation in this report is approved, the panel will meet the gender balance policy, with seven men and seven women appointed.

The Nomination Subcommittee submits the foregoing recommendation for Council's consideration.
