**IN CAMERA RATIONALE**

**RECOMMENDATION**

THAT Council nominate Paul Mochrie, Deputy City Manager, to represent the City of Vancouver on the E-Comm Board of Directors for the 2018-2019 term, such Board to be appointed by E-Comm shareholders at the June 21, 2018, Annual General Meeting.

**REPORT SUMMARY**

This report requests that Council appoint Paul Mochrie, Deputy City Manager, as the City's representative to the E-Comm Board of Directors for the 2018-2019 term.

## **REPORT**

### **Background/Context**

The City is a key member in E-Comm, a non-profit corporation providing emergency dispatch and radio services to its public sector members. As a shareholder in the Corporation, the City may appoint its representative at any time under the by-laws of E-Comm.

At the Annual General Meeting of the shareholders of E-Comm on June 21, 2018, the Board of Directors is to be appointed by the shareholders for the 2018-2019 term. The City of Vancouver is entitled to designate one individual for election to the Board of Directors of E-Comm. Paul Mochrie currently represents the City of Vancouver on the Board.

### **Strategic Analysis**

The E-Comm Board is primarily a stakeholder Board. All but four Directors are nominated by the shareholder municipalities and government agencies. The current Board is a mix of elected and appointed officials representing:

- BC Emergency Health Services
- Belcarra / Coquitlam / New Westminster / Port Coquitlam / Port Moody
- City of Delta / Delta Police Board
- City of Richmond
- Cities of Surrey and White Rock / Township of Langley – two representatives
- City of North Vancouver, District of North Vancouver, District of West Vancouver, Village of Lions Bay
- City of Vancouver
- Independent Police Boards – Abbotsford / New Westminster / Port Moody / Transit Police / West Vancouver
- Maple Ridge / Pitt Meadows
- Metro Vancouver
- Provincial Government – two representatives
- RCMP
- Vancouver Police Board

The Chair of the Board is an independent director, and there are three other independent directors from the business community.

The Board member may be a member of staff, an elected official, or someone independent of the City. E-Comm is a not-for-profit, provincially incorporated company that is owned by its shareholders and is generally subject to the laws governing private corporations in addition to the *Emergency Communications Corporations Act*.

Even though Directors are designated by the various shareholders, every Director has a legal obligation to act at all times in the best interests of the Corporation. Directors are required to sign a Code of Conduct and Conflict of Interest Guidelines.

Currently, the City has the largest financial and operational investment in E-Comm of any shareholder. Thus, it is important for the City to have a representative on the Board who takes an active role in understanding issues, influencing financial decisions, and guiding the general management and evolution of the company. Decisions made now will impact future costs, participation and overall success of the company.

***Implications/Related Issues/Risk (if applicable)***

***Financial***

The enhanced functioning of E-Comm is of paramount importance given increased competition for dispatch services and increased concerns of an earthquake. It will be critical for the CEO and senior team to work with the Board to ensure that the business works efficiently, effectively and continues to be a service of choice for dispatch across the region while bringing additional cities into the same radio network. Failure of this could require a larger financial subsidy from the City of Vancouver and other member municipalities and could reduce Lower Mainland municipalities' ability to communicate during an emergency.

***CONCLUSION***

The City is a key member in E-Comm, a non-profit corporation providing emergency dispatch and radio services to its public sector members. As a shareholder in the Corporation, the City may appoint its representative at any time under the by-laws of E-Comm. Paul Mochrie currently represents the City of Vancouver on the Board.
