Thank you for the enormous support you continue to show the music and culture sectors. Today will be remembered as a watershed moment for music in Vancouver.

With the consideration of re-zoning for NEFC Sub-area 6B (Plaza of Nations), we're an essential step closer to Vancouver's need for an extraordinary, new centre for independent music. As you've seen from the outpouring of community support for the Music Presentation Centre, there is great need for this centre, across all genres and all business models for music.

I strongly support the development of the Music Presentation Centre in Northeast False Creek.

I've reviewed the re-zoning documents, and while there is so much positive opportunity articulated in both the Administrative and Policy Reports and in the Memorandum from General Manager: Arts, Culture and Community Services, I do want to raise a few concerns I have noted about the governance, operation, and economic sustainability of the Music Presentation Centre. I am writing as a music-loving citizen who also has decades of professional experience with venues and music business operation.

Section (b) Clauses 70.(b), 70.(c), and 70(d.) (Policy Report page 16 of 49) refers to the design development of a bar, Food & Beverage Space, Catering Kitchen, admin space, and education room.

Section (c) Clause 50.(d) (Policy Report page 46 of 49) sates the describe all non-performances spaces as shared with the "Applicant can use the aforementioned venues when the City or its delegate(s) is not using them." What "not using them" means is not defined.

Section (c) Clauses 50.(e) and 50.(f) (Policy Report page 46 of 49) describe all non-performances spaces as shared with the Applicant and reasonably negotiated terms to ensure achievement of the City's programmatic outcomes.

It is essential for the Music Presentation Centre to have autonomy over its spaces and operations in order to deliver financial and operational success. A Music Presentation Centre that has exclusive use of its own bar, offices, and education spaces can ensure that citizens' and the music community's needs are met at the highest level. A music centre that sort-of controls only its performance venues — and not its lobbies and bars — not only lacks the control of its audience experience, it lacks the financial and extra-programming autonomy that can ensure innovation and sustainability.

I applaud the Cultural Services team for all their work on this project. We have a once-in-a-generation opportunity to pave a path for transformation of Vancouver's music scene, and I believe Vancouver (its citizens, its musicians, and the City itself) will be best served if the music presentation in Northeast False Creek is delivered by the Applicant to more closely resemble a CAC Contribution, allowing the centre to manifest its full potential outside the potential constraints of as-yet unarticulated shared use with the Applicant.

Dear Honourable Mayor and City Councillors,

Thank you for the opportunity to express my views on this development activity. I am an active member of the community and a very interested citizen on what is happening in the NEFC area.

I would like to express support for the development at 750 Pacific Boulevard (Sub-area 6B) and 777 Pacific Boulevard (sub-area 10C), with some important points to highlight and caveats. What is particularly commendable in this plan are the amenities provided for residents nearby and Vancouverites overall. This includes the music presentation centre, the gardens, the public spaces (including access to the green rooftop), ice rink, community centre and daycare.

We hope these spaces act to make our community more cohesive and also allow for a safe, clean and well programmed environment. We appreciate the commitment to collaborate on maintenance and management of these areas. The integration of car and bike sharing as well as paths to transit and pedestrian ways will aid in managing the volumes of traffic congestion. Again, we look forward to the collaboration in promoting these options so residents and visitors are aware and empowered to use them.

Now to an important caveat: Although we should strive to protect view corridors, not only for Cambie but for south False Creek and east to Main Street, we need to balance where this makes the most sense. There are important areas directly in NEFC (Sub Areas 6C and 6D) which currently have tall towers planned directly adjacent to park space (Sub Area 9) as well near the waters edge of False Creek. This simply should not be allowed to happen.

Sub area 10C in particular is where we should develop height and density as there is precedence for this on Georgia Street and this is directly adjacent to a busy entertainment area around BC place and Rogers Arena. If this is the compromise we need to support low rise development (2 - 4 stories) in the future next to park space and the waters edge, then so be it.

As we look at Sub Area 6B, the terracing of the residential building will prevent a feeling of a wall against the park and public spaces. This is critical to minimize the a claustrophobic feeling for citizens and residents trying to enjoy the edge of False Creek. This good design should be supported.

This is an important principal which should inflence all surrounding areas being developed in NEFC currently, including areas adjacent to the park on Sub Area 9. While recognizing different planning organization and stake holders are involved, COV along with city planners need to work with these groups to maintain a vision and an overall plan to ensure buildings directly adjacent to a

park or waterfront should be quieted and be a low rise structure. Ideally these locations should also work to benefit the business interests of the developers while providing for "places and spaces" for citizens.

This point cannot be stresses enough, the need for these public spaces and amenities to be maintained and programmed for the safety and benefit to our community. The increased density in the neighbourhood will continue to build a need for indoor and outdoor spaces which allow people to work, play and rest outside their small living spaces. The more we integrate and share spaces, the more we will realize a diverse and inclusive Vancouver.

Although we do not want to restrict investor involvement, where possible we want interested citizens to live in these new developments vs off-shore interests. The pre-sales for local residents should include access to all units. When the sales open for foreign buyers, they should be limited to one suite only (the same as the locals offer).

Thank you to all involved for your work and help to make this new area of Vancouver a successful residential and business community and a compelling destination.

### Supplementary Submission for the Re-Zoning of the Plaza of Nations: Proposal for Minor Amendments to Appendix B regarding the exclusive use of the proposed Music Presentation Centre by the City or its designate

The Vancouver Independent Music Centre Society is supportive of this historic move to secure a dedicated music centre for Vancouver.

However, as the music presentation centre may be co-located with a larger venue of which the costs and benefits are unknown, we feel it is essential that the City or its Designate has exclusive use of the entire music centre facility to support a sustainable business model. This will ensure that the provision of community programming will not be compromised, and that revenue generation from ancillary spaces, such as the lobby café/ bar, can support affordable presentation and education space.

We wish to suggest minor amendments to provide greater clarity of the terms and intent of Appendix B. In the Conditions of By-Law Enactment (pages 45-46), we propose removal of section 50 - (d), (e) and (f) and in the paragraph below, the removal of the words, "for the joint use of this centre (per above)" and the addition of a clause affirming that the City or its Designate will have exclusive use of the entire 20,000 square feet proposed for the music presentation centre.

These changes will give the City or its Designate complete control over the Centre's accessibility, its long term operational sustainability and capacity for change through thoughtful programming and well managed operations.

We thank the Mayor and Council and its staff for recognizing the value and need for a successful, supportive and sustainable music centre for Vancouver in this application for rezoning of the Plaza of Nations.

1. We will not be able to run any programs during Rogers Arena event days. Due to traffic and cost of parking.

2. The facility will be used for the best interest of the Aquilini group and not the general public in eluding minor ice sports.

Even with these corns Van Minor is in favour of the new rink and it would help to alleviate some of the ice shortages we are dealing with. And in turn would allow us to keep more of our programming within the city limits of Vancouver. Currently we acquire over 10 hours of ice on a weekly basis outside the city to maintain our minimum level of programming for our over 550 members. Having to travel outside the city for ice time increases the costs and participation barriers for our members and is something we need to avoid to ensure we can stay sustainable moving forward.

To whom it may concern,

I was scheduled to speak on Tuesday evening at the Public Hearing on the Plaza of Nations Re-Zoning which will include the Music Presentation Centre. I understand the schedule did not allow for this issue and it has been rescheduled for this evening when, unfortunately, I cannot attend. I would like to present my thoughts in writing here in lieu of speaking in person.

Firstly, I would like to give a resounding thank you to the council for being supportive of the Music Presentation Centre project thus far and for being clear about their dedication to arts and culture in Vancouver.

I am a JUNO Award winning songwriter, composer, recording artist and business owner who has lived most of my life in Vancouver. For several years, I sat on the board of the Vancouver Independent Music Society which has fostered nearly a decade of developmental studies, consultations, and relationship building with the firm goal of creating a non-profit hub for all things music-related in Vancouver.

Traditionally, musical performance has largely existed in the private sector - in bars, clubs and theatres. What this means for most musicians is that their art and work is an accessory/means to alcohol sales. This is not, in and of itself, a bad thing, but it does paint the industry with a particular colour. We have an opportunity here to make a gratuitous statement about music's place in our hearts and minds as a city. We have a dance centre. We should also have a music centre. I speak not of a place that simply competes with existing private music schools, venues and organizations, but one that collaborates and provides a comfortable and welcoming meeting place for them all to cross-polinate.

I believe that as Vancouver struggles with an ever apparent affordability crisis, it is increasingly important that we make truly pointed choices about how we want our city to *feel*. We need to be very clear about what kinds of characteristics we want attributed to Vancouver. As it is the creative community which contributes most veritably to the cultural vibrancy of the city, we need to make it attractive for that creative community to stay living here - and we need to set down firm, long-term entrenched institutions and facilities that broadcast our shared belief that culture is important to a healthy society.

I speak not only of musicians, but of the general public. People need not be professionally involved in music for it to affect their lives in profound ways. In terms of performance spaces, Vancouver is severely lacking in *intimate listening rooms*. Beyond programming, community engagement and varied educational interests, this presentation centre would offer a ground-breaking facility that puts *listening* at the very heart of its philosophy. Not to be overly dramatic or hyperbolic, but I do believe at this point in time that *listening* is something that the world could benefit from making fruitful practice of.

This facility would have been extremely helpful in the teeth-cutting days of my artistic life, and it is within the walls of creative hubs like this where magical, sometimes unexpected and world changing art scenes can find genesis. Not only would a Music Presentation Centre add reason for our current musician base to remain in

Vancouver, but it could foster wildly unknown results in how the youth of today develop into mature artists and attract an influx of creative people to Vancouver from all over the world.

Furthermore, I would like to recommend the removal of Appendix B, Item 50 (d), (e) and (f) and ask for a clause giving the City or its designate exclusive control over the whole music presentation centre. If we are to be bold in bestowing an important mandate upon a revolutionary type of facility, it should not be beholden to the whims of its landlord in the execution of that mandate.

Thank you sincerely for your time and consideration. I truly hope to see this exciting project come to fruition in the near future.
