The Arbutus Shaughnessy Kerrisdale (A.S.K.) Friendship Society is a registered charity that provides Adult Day Program Services in Vancouver B.C. We currently provide services to the neighbourhoods of Arbutus, Shaughnessy, Kerrisdale, Marpole and Oakridge. Adult Day Programs provide services to seniors in the community that require more support due to physical or mental health challenges in an effort to reduce social isolation and caregiver stress. Adult Day Programs offer a safe space with therapeutic activities, socialization, healthy home-style lunches, transportation management and health monitoring. Programs such as A.S.K. allow seniors to live longer in the community in their own home. When our members are engaged at the program, the family caregivers benefit from five hours each day of much needed respite, helping to reduce caregiver stress.

In 2012, A.S.K. was named by Vancouver City Council as one of the community groups to occupy the community space in the Arbutus Centre. We are very grateful that the City of Vancouver named A.S.K. to provide senior services in this location. Since then, we have been eagerly waiting to occupy this space in order to serve the seniors and families in these communities. There is a growing need for senior services in our communities and with this space will be able to help fill this important need for seniors and their families.

A.S.K. has been in communication with the City of Vancouver and Larco to hear updates on the project and to provide information on our unique needs as it relates to the development. We are thankful that the City of Vancouver is providing A.S.K. with community amenity space to run our program in block C. If more square footage is allocated to the A.S.K. Friendship Society through this new proposal we would welcome the additional space with gratitude. Senior services are an important and increasing need for our communities. With a larger space, A.S.K. would be able to accommodate more seniors and their families in our program now and in the future.

The Association of Neighbourhood Houses has operated in Vancouver since 1894. Currently we service the Westside through the Kitsilano Neighbourhood House and is involved in Community Development, Family Services, Seniors support, Seniors Housing, Hosuing for those with disabilities, Children's Programs including Daycare, drop-ins, out of school care and related services. We provide many other community based services as well.

The proposed Arbutus Centre includes an expanded Neighbourhood House to be based in the building to provide similar services to the community. We see this as necessary to better support and grow the larger Arbutus area of the West Side. It will be a good base to extend services for those moving in to the accommodation and in the area generally.
