

# **Rezoning Policy**



- Oakridge Transit Centre (OTC) and Adjacent Sites Policy Statement
  - Approved by Council in December 2015
  - Allows consideration of redevelopment of OTC site and three adjacent sites, including the JCC
  - Supports renewal and expansion of JCC facility
- 37th Ave St Baillie 38th Ave 39th Ave OAKRIDGE **Osler St** Oak St Willow St TRANSIT CENTRE Petro Canada Oakmont **Gas Station Medical Centre** 41st Ave Jewish **Community Centre**


#### **Project Details**

- 9-storey JCC replacement
- 26-storey and 24-storey residential buildings over a podium
- 299 social housing units (77% family units)

- Doubling of JCC program space
- Maximum height of 88 m (289 ft.)
- 4.49 FSR

### Phase 1





#### **New JCC facility**

- 9-storey JCC replacement
- 37 m (122 ft.) maximum height
- Aquatic centre
- Auditorium
- Gymnasia and Fitness Studio
- Multi-purpose rooms
- Community offices and lounges
- Adult daycare centre
- Early Childhood Education Centre providing private childcare spaces
- Commercial/retail space at grade




- Renewal of JCC, community use, new affordable housing, building design

#### **Focus of New Development**

- Adjacent to Oakridge Municipal Town Centre (MTC) and near Oakridge Centre mall site
- Significant population and job growth anticipated

#### **Recent Policies Approved:**

 Oakridge Transit Centre and Heather Lands policy statements

#### **Anticipated Building Heights**

- Oak Street and 41st intersection consider 6-20 storey buildings
- OTC consider 3-15 storey buildings
- Oakridge Cenre and MTC features buildings up to 44 storeys






