1a. 2019 Annual Review of Water Rates and Water Works By-law Amendments November 27, 2018

MOVED by Councillor Carr SECONDED by Councillor Fry

- A. THAT Council approve, in principle, proposed amendments to the Water Works By-law related to housekeeping and billing, generally as set out in Appendix B of the Administrative Report dated November 27, 2018, entitled "2019 Annual Review of Water Rates and Water Works By-law Amendments".
- B. THAT Council approve the 2019 rates and fees under the Water Works By-law, with the following recommended increases: 9.7% increase in the per unit flat fee for Single Dwelling (from \$653 per unit in 2018 to \$716 per unit in 2019); 9.7% increase in per unit Metered Rate in off season (from \$2.849 in 2018 to \$3.125 in 2019) and peak season (from \$3.571 in 2018 to \$3.917 in 2019); 2.2% increase

for Water Flat Rate Connection Fees for Single and Two Family dwellings; 2.2% for all other Water Flat Rate Connection Fees (as listed in Appendix A of the Administrative Report dated November 27, 2018, entitled "2019 Annual Review of Water Rates and Water Works By-law Amendments", Schedule A); and varied increases for all other Water Utility User Rates (as listed in Appendix A of the above-noted report, Schedules B, C, E, F, G and H).

C. THAT Council instruct the Director of Legal Services to bring forward for enactment the necessary amendments to the Water Works By-law, generally as set out in Appendix B of the Administrative Report dated November 27, 2018, entitled "2019 Annual Review of Water Rates and Water Works By-law Amendments".

2b. 2019 Annual Review of Sewer Rates and Environmental Updates Under the Sewer & Watercourse By-law November 27, 2018

THAT Council approve, in principle, proposed amendments to rates and fees in the Sewer & Watercourse By-law for 2019, generally as set out in Appendix A of the Administrative Report dated November 27, 2018, entitled "2019 Annual Review of Sewer Rates and Environmental Updates Under the Sewer & Watercourse By-law", including the following recommended increases: 11.0% increase in the per unit flat fee for Single Dwelling (from \$424 per unit in 2018 to \$471 per unit in 2019); 11.0% increase in Other Sanitary Sewer User Rates (as listed in Appendix A of the above-noted report); 11.0% increase in per unit Metered Rate (from \$2.729 in 2018 to \$3.030 in 2019); 11.0% increase in the per unit Waste Discharge Permit User Rate (from \$0.8991 in 2018 to \$0.9980 in 2019); and, 2.2% increase in Flat Rate Sewer Connection Fees; 2.2% increase for inspection of a plumbing system, subsoil drainage pipes and a building sewer fees (as listed in Appendix A of the above-noted report, PART I).
- B. THAT Council instruct the Director of Legal Services to bring forward for enactment the necessary Sewer & Watercourse By-law amendments, generally as set out in Appendix B of the Administrative Report dated November 27, 2018, entitled "2019 Annual Review of Sewer Rates and Environmental Updates Under the Sewer & Watercourse By-law".

THAT Council instruct the Director of Legal Services to bring forward for enactment amendments to the Solid Waste by-laws to adjust rates and fees and make other miscellaneous related amendments generally in accordance with the Administrative Report dated November 27, 2018, entitled "2019 Solid Waste Utility (SWU) Fees & By-law Changes", and in Appendix B of the same report.

- C. THAT Council adjusts fees to recover City costs related to certain fees under the Street Utilities By-law No. 10361.
- D. THAT Council adjusts fees to account for penalty for congestion inducing on-street parking under the Street and Traffic By-law No. 2849.
- E. THAT the Director of Legal Services be instructed to prepare by-laws to amend the Encroachment By-law No. 4243, Street and Traffic By-law No. 2849, Crossing By-law No. 4644, Street Distribution of Publications By-law No. 9350, Street Utilities By-law No. 10361, Street Vending By-law 10868, Granville Mall

By-law No. 9978, and the By-law Notice Enforcement By-law 10201, all generally in accordance with Appendix B of the Administrative Report dated November 6, 2018, entitled "2019 Engineering Fees".

1e. False Creek Neighbourhood Energy Utility ("NEU") 2019 Customer Rates November 20, 2018

MOVED by Councillor Kirby-Yung SECONDED by Councillor Carr

- A. THAT Council approve, in principle, the proposed amendments to the Energy Utility System By-law ("the By-law"), generally as set out in Appendix A of the Administrative Report dated November 20, 2018, entitled "False Creek Neighbourhood Energy Utility ("NEU") 2019 Customer Rates", including:
 - I. the 2019 customer rates and fees, with a 3.2% increase over 2018 customer rates. In accordance with Council Policy to improve the energy conservation price signal, this 3.2% increase is to be achieved by increasing the Fixed Capacity Levy by 2.6% and the Variable Energy Charge by 4.0%;
 - II. an Initial Connection Levy for future Neighbourhood Energy Utility ("NEU") customer buildings, in the amount of \$85,000, plus \$100 per kilowatt of peak energy demand associated with the respective customer building; and
 - III. greater design flexibility for customer buildings, and miscellaneous amendments including billing issues.
- B. THAT Council instruct the Director of Legal Services to bring forward for enactment the By-law amendments, generally as set out in Appendix A of the Administrative Report dated November 20, 2018, entitled "False Creek Neighbourhood Energy Utility ("NEU") 2019 Customer Rates".
- C. THAT Council update key performance indicators ("KPIs") and targets as set out in the Administrative Report dated November 20, 2018, entitled "False Creek Neighbourhood Energy Utility ("NEU") 2019 Customer Rates", to guide future rate setting for the NEU under the commercial utility rate model.

1f. 2019 Capital and Operating Budget November 16, 2018

MOVED by Councillor Fry SECONDED by Councillor Boyle

- A. THAT Council approve \$27.8 million for the following five investment areas included in the 2019 Operating Budget, as detailed in Appendix 1 of the Administrative Report dated November 16, 2018, entitled "2019 Capital and Operating Budget", and comprising the following:
 - i. \$7.7 million for initiatives to address housing supply and affordability and improve availability and supports for renters and vulnerable citizens;
 - ii. \$7.7 million for initiatives to improve and maintain service levels;
 - iii. \$5.4 million for initiatives to increase investments in public safety;
 - iv. \$3.7 million for initiatives to continue to build vibrant communities and public spaces that support arts, culture and the environment; and
 - v. \$3.2 million for initiatives to provide safe and healthy workspaces and public spaces.
- B. THAT Council approve the Vancouver Board of Parks & Recreation 2019
 Operating Budget of \$128,124,175 in expenditures, and \$61,597,742 in fee and program revenues as outlined in Appendix 1 of the Administrative Report dated November 16, 2018, entitled "2019 Capital and Operating Budget".
- C1. THAT, subject to approval of A above, Council approve the Vancouver Police Board 2018 Operating Budget for collective agreement contracts of \$263,624,330 in expenditures. At the end of 2018, the arbitrated settlement between the Vancouver Police Union and the Vancouver Police Board will expire. The 2019 VPD budget does not include wage increases related to the Vancouver Police Union.
- C2. THAT, subject to approval of A and C1 above, Council approve the Vancouver Police Board 2019 Operating Budget of \$317,287,565 in expenditures, and \$22,921,167 in revenues as outlined in Appendix 1 of the Administrative Report dated November 16, 2018, entitled "2019 Capital and Operating Budget". Included within this amount is a budget of \$2,581,530 in 2019 for the Vancouver Police Board to continue implementation of recommendations in the Vancouver Police Department Operational Review.
- D. THAT Council approve the Vancouver Public Library Board 2019 Operating Budget of \$54,075,149 in expenditures, and \$4,932,000 in fee and program revenues as outlined in Appendix 1 of the Administrative Report dated November 16, 2018, entitled "2019 Capital and Operating Budget".

- E. THAT Council approve the 2019 Property Endowment Fund (PEF) Operating Budget of \$61.5 million revenue and \$61.5 million expenses (including transfers) as outlined in Appendix 1 of the Administrative Report dated November 16, 2018, entitled "2019 Capital and Operating Budget".
- F. THAT, subject to approval of A, B, C, and D above, Council approve the budget resolution attached as Appendix 2 of the Administrative Report dated November 16, 2018, entitled "2019 Capital and Operating Budget", thereby adopting the final 2019 Operating Budget of \$1,516,474,153 as outlined in Appendix 1 of the above-noted report, with a property tax increase of 4.9%, comprised of 1.0% to fund additional investments in infrastructure renewal approved in the 2019-2022 Capital Plan, 1.7% to cover increased costs related to the provincial government's new Employer Health Tax, and 2.2% to cover inflationary and wage costs of existing services, and new investments as outlined in A above, to maintain and improve services.

And THAT, subject to approval of F above, Council approve the following related to the 2019 Capital Budget:

- G1. THAT Council approve \$1.6 million for renewal of VPD Patrol vehicles, funded from the Plant and Equipment Reserve;
- G2. THAT, subject to approval of recommendation G1, Council approve funding sources for new Capital Projects to begin in 2019 in the amount of \$371.1 million as outlined in Appendix 1 of of the Administrative Report dated November 16, 2018, entitled "2019 Capital and Operating Budget", with specific project funding detail provided in Appendix A of the same report, of which \$302.4 million is budgeted as expenditure in the 2019 Capital Budget and \$68.7 million is forecast to be spent in future years for projects spanning multiple years.

 - FURTHER THAT staff engage the property Tax Policy Review Commission and report back by April, 2019 regarding the opportunity and impact of a 2% tax shift.
- M. THAT Council direct staff to ensure that 2019 property tax notices clearly break out property taxes, charges levied for the new Employer Health Tax imposed by the Province of BC, and Utilities including Metro Vancouver charges, in order to provide clear and transparent information to residents on the fees being charged.

- N. THAT Council direct \$20 million of available Empty Homes Tax revenue, when it is received, for initiatives to address housing supply and affordability, to improve availability and supports for renters and vulnerable citizens, and to deepen affordability of social housing for people experiencing homelessness, people on social assistance and disability and people on pensions; and that staff report back on options for this funding.
- O. THAT, as the Indigenous Healing and Wellness Centre has been in planning for some time with budgets allocated in 2018, Council direct staff to work with senior governments and partners, as well as Downtown Eastside residents who are potential users of the Centre, to deliver on the funding already allocated and report back on the plans and any additional funding requirements in order to get this project underway in 2019 and complete the project in a timely fashion.
- P. THAT Council direct staff report back in Q1 2019 with a plan for an enhanced budget development process for the upcoming 2020 fiscal year and future fiscal years that includes:
 - a. a strategy planning session with Council early in each fiscal year to review and establish strategic directions and priorities;
 - b. budget workshops with Council to establish an iterative and informed budget development process, including proposed property tax increases, as well as savings and spending proposals; and
 - c. multi-year department service plans to support planning and transparency.

FURTHER THAT the Operating Budget Policy (ADMIN-004) and Capital Budget Policy (ADMIN-005) be updated to incorporate these best practices and inform the annual budget development process.

- Q. THAT Council direct staff to review the City of Vancouver's current financial investment in and benefit from the Vancouver Economic Commission and report back in Q1 2019 on:
 - a) how this investment aligns with emerging Council priorities
 - b) how some of this investment could be redirected to support other core city priorities in the 2020 operating budget.
 - c) any consultations staff have with stakeholders in Vancouver that have a mandate to promote economic development and trade; including but not limited to the Greater Vancouver Board of Trade.
- R. THAT Council direct staff to reduce the 2019 operating budget by eliminating \$2 million from Council contingency;
 - FURTHER THAT Council direct staff to apply the funds towards a property tax reduction.
- S. THAT, in order to allow Vancouver Fire and Rescue Services to meet the best practice recommendations found in the Darkhorse needs assessment, Council

commit to fully funding the remainder of the recommended plan including 122 new staff, over the five year period from 2019 to 2023, shifting any necessary staffing commitments not met in this 2019 budget to be split between 2020 and 2021 to make up the difference.

- T. THAT Council allocate the Community Amenity Contribution's in the amount of approximately \$5,381,000 to capital costs for non-market and supportive housing, and direct staff to report back as soon as possible.
- U. THAT Council direct staff to transfer a portion of 2018 revenues from the Empty Homes Tax to a program to reduce the cost of permitting, licensing and planning for residential homeowners and taxpayers to legalize secondary and/or basement rental suites in single family residential dwellings.
 - FURTHER THAT staff report back with a program and plan, including the possibility of limiting rents or rent increases in the basement suites that benefit from the reduced cost of permitting and licensing, in Q2 2019, including plans for implementation of the program no later than Q3 of 2019.
- V. THAT staff increase by 50% the number of streetscape public recycling stations across the city from 100 to 150 starting in 2019 and that staff reallocate funding within the Solid Waste Utility that is currently allocated toward installing additional street side garbage cans to support the installation and servicing of these stations and request Recycle BC to partner with the City of Vancouver in funding these stations as they have with other streetscape public recycling stations.
- W. THAT Council direct staff to reduce the 2019 operating budget by eliminating 1 million from the Innovation Fund and applying the funds towards a reduction in property tax.
- X. THAT Council direct the Mayor, on behalf of Council, to immediately write a letter to the Premier, and the Minister responsible for Mental Health and Addictions and request immediate funding in the amount of \$595,770 to be applied to Public Safety and specifically renovations to be allocated to cover the City of Vancouver costs for renovations of Vancouver Police Department Safe Drug Lab.

2. Building a Family Friendly Vancouver: Affordable Child Care

Following the Standing Committee on City Finance and Services meeting on December 5, 2018, Vancouver City Council referred discussion and decision on the above noted motion to the Regular Council meeting on December 18, 2018.

MOVED by Councillor De Genova SECONDED by Councillor Dominato

WHEREAS

1. Vancouver is facing an affordability crisis. A lack of affordable housing and

- affordable childcare are limiting the abilities of families to continue to live in the city of Vancouver;
- 2. In 2018, the Provincial Government released "Childcare B.C., Caring for Kids, Lifting up Families: The Path to Universal Childcare". The document states "Vancouver is one of the most expensive cities for Childcare with a median fee of \$1,250 per month for infant and toddler care". The document also commits to providing grants to local governments in British Columbia to support building new child care spaces and creating plans to inform local needs;
- 3. On June 26, 2018, The City of Vancouver issued a press release celebrating 1064 new child care spaces. On the City of Vancouver website, Mayor Gregor Robertson is stated as saying "Making sure that families have access to affordable childcare is a key part of building a healthy, inclusive city and helps set our kids up for success now and down the road";
- 4. The City of Vancouver Document "Technical Guidelines" published by Real Estate and Facilities Management in May of 2018 states that "Development Permits may be required for new childcare facilities. Building and Occupancy Permits are required for all new childcare facilities;
- 5. A Child Care Facility's childcare license will need to be obtained by the Childcare Operator from Community Care Facilities Licensing, a department of Vancouver Coastal Health, before an Occupancy Permit can be obtained. Nowhere in the document does it state that there is a policy to streamline and expedite the processes associated with permits and licensing for new childcare facilities;
- 6. The City of Vancouver Document "Steps for Establishing a Child Care Centre in an Existing Building" published by the Social Development Department was last updated in 2008;
- 7. The City of Vancouver website page "Developing a childcare centre" states "Staff work with developers, architects, landscape architects, and early childhood educators to make sure that every new center includes urban design best practices, and contributes to a child's mental and physical development". There is no mention of incentives or expediting the processes for childcare facilities in Vancouver.
- 8. On September 19, 2018, the motion entitled "Family Friendly Vancouver: Citywide Policy to Fast Track and Expedite Projects that include new Child Care Centres in the City of Vancouver" was referred to staff. It is anticipated that staff will report back to Council in June 2019.
- 9. On September 2018, the British Columbia Ministry of Children and Family Development issued a press release titled "Partnerships give B.C. families quicker access to child care". The release states "Municipal and regional government in B.C. are eligible for up to \$1 million per project through the new Community Child Care Space Creation Program. Priority will be given to projects that build spaces that serve infants and toddlers, offer care outside of regular

- business hours, are operated by a public body or non-profit, and/or benefit underserved populations".
- 10. Phase 1 Actions of the Women's Equity Strategy include "Identify child-friendly provisions to accommodate participation by families with children at Council and public hearings at City Hall.

THEREFORE BE IT RESOLVED

- A. THAT Council directs the City of Vancouver staff to formally contact the appropriate Ministry of Children and Family Development staff to discuss opportunities for the City of Vancouver to secure funding for future projects from the Community Child Care Space Creation Program and report back to Council within the potential for provincial funding.
- B. THAT Council direct staff to explore ways the City of Vancouver can work with organizations and agencies including Vancouver Coastal Health and the B.C. government to streamline and expedite the processes associated with permits and licensing for child care facilities in Vancouver.
- C. THAT Council direct staff to explore a program to create incentives for applicants to include child care in future developments and report back to Council in spring of 2019; however, if funding from senior levels of government becomes available sooner, that staff prioritize and expedite a report and any recommendations to Council.
- D. THAT Council direct staff to consider purpose-built child care, including temporary structures similar to modular housing when appropriate;
 - FURTHER THAT staff consider requirements for child care facilities to be included; when appropriate, on any development of City Owned Land.

AND WHEREAS the total estimated gross expenditures of the City to pay all debts and obligations of the City falling due in the year 2019, exclusive of the amounts required for school, Greater Vancouver Regional District, Greater Vancouver Transportation Authority, British Columbia Assessment Authority and Municipal Finance Authority purposes and not otherwise provide for, as amended by Council, amount to \$1,513,474,153;

AND WHEREAS the total estimated expenditures as aforesaid is the sum of the appropriation requests of all departments and boards properly supported by detailed analysis of those expenditures and listings of the salaried staff;

AND WHEREAS the total estimated revenue of the City for 2019 from sources other than real property taxes, as amended by Council, amounts to \$722,646,213; AND WHEREAS the amount of the General Purposes Tax Levy so required is \$790,827,940;

THEREFORE be it resolved that the said estimates, both as to totals and individual items pertaining thereto, of the Director of Finance as so amended by Council be and the same are hereby adopted by Council.

B. Motions on Notice

1. Weddings at Vancouver City Hall

MOVED by Councillor De Genova SECONDED by Councillor Bligh

WHEREAS

- 1. City Halls across North America have traditionally served as venues for couples who are looking to have simple and small civil marriage ceremonies;
- 2. Most City Halls across Canada, offering civil marriage services or venues as a wedding, state that the time of a ceremony ranges between 10 and 20 minutes and can accommodate a range of 5 to 30 guests per wedding;
- 3. City Halls in Canada, including Victoria City Hall, Calgary City Hall, Fredericton City Hall, Ottawa City Hall and Toronto (both Old and New City Halls) offer the opportunity for couples to book in advance and hold wedding ceremonies on-site;
- 4. Some City Halls, including Toronto, offer City Hall weddings in a dedicated space. Offering weekends on set days (four days of the year) and typical non-business hours is a practice of many Canadian City Halls, including Victoria;
- 5. At Ottawa City Hall, couples can choose weekday or weekend options for weddings, at a cost ranging from \$141.30 for week day ceremonies to \$212.00 for weekends, subject to availability. A marriage license can be obtained on-site for a \$161.60 fee, if all requirements are satisfied. Ceremonies are offered in both English and French;
- 6. Although the Vancouver Board of Parks and Recreation offers couples the option of applying for permits to be married on designated and non-designated sites; the City of Vancouver does not currently have a program to permit weddings at Vancouver City Hall;
- 7. Vancouver City Hall opened December 4, 1936, and was designated a heritage building in 1976;
- 8. Vancouver City Hall was built by the architectural firm of Townley and Matheson. The City of Vancouver website states "On the third floor, the ceremonial and formal spaces including the Council Chamber are substantially intact. The chamber are two stories in height, with a rear wall balcony, central inset clock, high windows, large brass wall sconces, and beautifully veneered wall panels. The woodwork is lovingly detailed and is very well preserved. The four large modernistic cast brass suspended chandeliers, with obscure glass insets, still light the Chamber.

THEREFORE BE IT RESOLVED THAT in the spirit of increasing accessibility, welcoming the public and acknowledging the historical significance of Vancouver City Hall, Council directs staff to:

- Explore the possibility of offering Vancouver City Hall as a venue for weddings and civil ceremonies at and on the grounds of Vancouver City Hall;
- ii. Consider the structure City Halls across Canada practice in providing a venue for marriage and in some cases, providing services including resources to obtain a marriage commissioner, officiant or the necessary documents required for marriage in BC;
- iii. Report back to Council with recommendations, including any budget implications, and recommendations for the possibility of a pilot or trial program for holding weddings on set days of the year, or regularly at Vancouver City Hall:
- iv. Consideration to Council Chamber, Helena Gutteridge Plaza and the garden at Vancouver City Hall are considered as possible options for weddings in any recommendations brought back to Council for consideration;
- v. Staff will report back to Council with recommendations by December 2019.

2. Improving Resident Participation at City Council

WHEREAS

- Meetings of Vancouver City Council are governed by the Procedure By-law No. 9756 which was enacted on November 25, 2008, and consolidated for convenience to March 27, 2012;
- Hearing from residents of Vancouver and providing residents the opportunity to speak to City Council on civic matters is an important and fundamental aspect of our democratic process;
- 3. The current processes governing or being followed regarding hearing of speakers at Council and Committee meetings are inefficient and unpredictable for residents and are resulting in long delays with speakers oftentimes waiting for hours on end for the opportunity to address Council on their desired agenda item. Speakers are often pushed to late in an evening, the following days or even the following week;
- Current processes often result in speaker drop-off as residents have jobs and commitments, varying circumstances, accessibility needs and transportation considerations. Conditions are not being created to allow our diverse voices in the city to be heard;
- 5. Council has a responsibility to maximize the ability for residents to participate in their local civic government and to reduce barriers.

THEREFORE BE IT RESOLVED THAT Council direct staff to report back before the end of January 2019 with recommendations and proposed changes that could improve the process and predictability for the scheduling of speakers for items on Council agendas;

BE IT FURTHER RESOLVED THAT recommendations give consideration but are not limited to, the ability or option to hear speakers on member motions on the relevant Council day versus automatic referral to Standing Committees, as well as the potential to schedule specific time slots and speaker times. Additionally, that staff indicate any required updates to Procedure By-law No 9765 accompanying the recommendations, with the goal of improving resident participation and experience at Vancouver City Council.
