I submit this email as a response to the Public Hearing on this rezoning. I had originally signed up as Speaker #36 for February 20 but as the meeting was extended and I am unable to attend in person, I felt that this email would be the most expedient way to register the Bloom Group of Community Services support for the rezoning.

For over 60 years, the Bloom Group has provided services and support to vulnerable people across the Lower Mainland. Last year we served over 2,000 people in over 800 units of housing; 500 permanent homes, shelter and transitional housing for 70 families and almost 200 people a year in the hospice program.

We support this rezoning and in particular the 90 units of social housing.

Without these types of housing options, many of the women led families we serve cannot move out of their short term housing services. This means that families live in shelters and transitional housing for several years. These families have successfully created lives for themselves and now require permanent housing. On the other end, women and families who require shelters to leave homelessness or precarious living situations cannot access the needed services. Without new homes, the services freeze and new families may not be served.

We have experience in providing resources for people to change their situations with housing, services, support and advocacy. We believe that communities encompass a wide variety of citizens; for both current and future residents. The impact of permanent is profound and has shown time and time again to be a fundamental pillar that allows families to attain their goals.

With an eye to a dynamic community and to further the goals of the City, we support the rezoning and look forward to more opportunities to serve and support
