**3. Contract Award for Construction Services for Pile Driving
February 13, 2019**

THAT the Committee recommend to Council

THAT Council authorize City staff to enter into a contract with Surespan Construction Ltd., for pile driving of timber piles as part of the new parks for the East Fraser Lands development with an estimated contract value of \$4,564,274.89, plus applicable taxes over the initial three-year term, to be funded from the available approved multi-year EFL Shoreline Protection capital project budget.

 - ii. Standard hours of operation for the first three months limited to 11 am to 2 am, seven days a week after which time Extended Hours of operation may be considered which are limited to 9 am to 3 am, seven days a week;

- iii. The outdoor patio ceasing all liquor service and vacated by 11 pm nightly;
 - iv. Acoustic report to be submitted certifying that the establishment meets Noise Control By-law requirements;
 - v. No music or entertainment permitted on the patio;
 - vi. Signing a Good Neighbour Agreement with the City prior to business licence issuance;
 - vii. A Time-Limited Development Permit;
 - viii. Food service to be available while the establishment is operating as well as on the patio when open; and
 - ix. The termination of Liquor Primary licence #301999 which is for Republic Nightclub (277 persons) in support of this application.
- B. THAT Council, having considered the opinion of local area residents and business operators as determined by neighbourhood notification, site sign, noise impacts and relevant Council policy as outlined in the Administrative Report dated February 15, 2019, entitled “855 Granville Street – Cineplex Entertainment LP by its General Partner Cineplex Entertainment Corporation (The Rec Room) – Two New Liquor Primary Licence Applications - Liquor Establishment Class 1 (Third Level Rooftop) with Outdoor Patio and Venue (Lower Level)”, endorse the request by Cineplex Entertainment LP by its General Partner Cineplex Entertainment Corporation for a new 646 person Provincial Liquor Primary licence for an event driven venue located in the lower level of this multi-level recreational/dining complex/dining located at 855 Granville Street subject to:

 - iv. Acoustic report to be submitted certifying that the establishment meets Noise Control By-law requirements;
 - v. Signing a Good Neighbour Agreement with the City prior to business licence issuance; and
 - vi. A Time-Limited Development Permit.

**5. 777 Richards Street – The Alley Bar (Telus Garden) - Liquor Primary Liquor Licence Application - Liquor Establishment Class 1

The Committee heard from three speakers; two who spoke in support of the application and one who spoke in general support but had reservations concerning noise and hours of operation and requested the six month trial period be extended to one year.

- ii. Standard Hours of operation, for the first six months, limited to 11 am to 1 am, Sunday to Thursday, and 11 am to 2 am, Friday and Saturday; after which time Extended Hours of operation may be considered which are limited to 9 am to 2 am, Sunday to Thursday, and 9 am to 3 am, Friday and Saturday;
- iii. A Time-Limited Development Permit;
- iv. Food service to be available while the establishment is operating;
- v. An acoustic report to be submitted certifying that the establishment meets Noise Control By-law requirements; and
- vi. Signing a Good Neighbour Agreement with the City prior to business licence issuance.

7. Helping Campers in Oppenheimer Park

On February 26, 2019, Vancouver City Council referred this matter to the Standing Committee on City Finance and Services meeting on March 13, 2019, in order to hear from speakers.

Prior to hearing from speakers, Council agreed to consider amendments to the original motion which were put forward by Councillor Swanson.

MOVED by Councillor Swanson
THAT the Committee recommend to Council

WHEREAS

1. There are currently 80-100 people camping in Oppenheimer Park in below freezing temperatures;
2. Most are living with makeshift shelters, with insufficient bedding, lack of proper nutrition and no formal source of heat;
3. The elderly and vulnerable are more susceptible to illnesses exacerbated by cold, and may be already living with chronic illnesses;
4. There are reports of pneumonia in the park already;
5. Campers cannot safely leave their belongs to go to shelters, emergency response shelters or warming centres or to the hospital for fear of having their belongings thrown away;
6. Shelters are too often full or not able to meet the needs of campers with partners, pets or belongings;
7. Campers have had belongings destroyed or taken by City staff;
8. Park washrooms are only open until 5 pm;
9. It is costly to pay City engineering and rangers to take down tents and clean up garbage; and
10. While most people agree that tent cities are not a good way to live, when there is no housing or shelter available people can be safer in a tent city than being alone on the street.

THEREFORE BE IT RESOLVED

- A. THAT Council direct staff to work with BC Housing to rent a hotel or motel to house the Oppenheimer Park patrons.
- B. THAT, in the interim, Council direct staff to acquire or implement a warming station in Oppenheimer Park with large heated tents, staffed with Peer Workers to help ensure safety and cleanliness.
- C. THAT Council direct staff to provide storage for belongings and washroom facilities for park patrons.
- D. THAT Council direct staff to ensure there is a way for campers to keep and/or retrieve their possessions.

- E. THAT Council direct staff to talk to Oppenheimer Park staff and patrons about other possible solutions to humanize being homeless when there is no housing to move to.

9. *The calendars of Vancouver City Councillors are not currently released proactively;*
10. *Proactive, routine disclosure of information builds public trust and makes it easier for citizens to participate in the political process and scrutinize government behaviour.*

- B. THAT Council direct City staff to work with Park Board staff and with the Civic Asset Naming Committee and the Descendants of the Komagata Maru Society to try to find an asset to name.
