REPORT SUMMARY

This report recommends appointments to 16 advisory bodies.

COUNCIL AUTHORITY/PREVIOUS DECISIONS

On December 11, 2003, City Council approved selection criteria for appointments to civic agencies, and the establishment of a Nomination Subcommittee of Councillors to screen applications in accordance with those criteria. On January 13, 2004, City Council approved the selection process for making appointments.

On November 5, 2018, Councillors Rebecca Bligh, Christine Boyle and Michael Wiebe were appointed to the Nomination Subcommittee.

On March 6, 2019 City Council approved a diversity policy which requires the City to aspire to achieve the following composition on each advisory body:

- Membership of fifty percent (50%) or greater of people from equity-seeking groups.
- Membership of fifty percent (50%) or greater of people who self-identify as women.

In the event where during the appointment process Council cannot meet the membership objectives set out in this policy, due to lack of sufficient applicants or for another reason, a temporary appointment of one year or less may be used to fill a vacancy.

CITY MANAGER'S/GENERAL MANAGER'S COMMENTS

The City Clerk recommends approval of the foregoing recommendations, noting the recommendations are generated from the aforementioned Council-approved nomination process.

REPORT

Background/Context

Section 160 of the *Vancouver Charter* requires that committees stand discharged at the end of the current Council term. As such, all advisory committees were released on November 4, 2018.

On February 27, 2019, Council established 12 Type A, and 3 Type B, advisory bodies.

The recommendations contained in this report will fill vacancies on advisory bodies. The majority of these vacancies exist due to the recent establishment of 15 advisory bodies by the current Council. The vacancies on the PNE Board of Directors occurred due to term completion.

On April 29, 2019, the Chair of the Nomination Subcommittee circulated all applications received to Mayor and Council via email, and welcomed input.

Term end dates for each advisory body align with their associated terms of reference, By-laws, or other legislation.

Approximately 725 applications were received for the advisory bodies noted in this report. The Nomination Subcommittee has reviewed the applications and submits the foregoing recommendations for Council's consideration.

The Nomination Subcommittee has reviewed applications for the 16 advisory bodies noted in the recommendations and recommends approval.
