THAT the General Manager of Arts, Culture and Community Services (GM of ACCS) is authorized to negotiate and execute agreements to disburse the grants described in the Administrative Report dated April 30, 2019, entitled "2019 Cultural Grant Allocations (Community Arts, Cultural Infrastructure)", on the terms and conditions generally set out below, and on such other terms and conditions as are satisfactory to the GM of ACCS and the City Solicitor.
- E. THAT no legal rights or obligations are created by the approval of A to B above unless and until the applicable grant agreement or letter of agreement is approved by the City in accordance with D above and executed and delivered by both the grant recipient and GM of ACCS (or their designate).

THAT Council approve 40 Theatre Rental Grants to the institutions listed in the Organization column of Appendix A in the Administrative Report dated April 30, 2019, entitled "Theatre Rental Grant Allocations Fall 2019 and Spring 2020", in the amounts set out beside their names in the "Sept 1-Dec 31, 2019 TRG Recommendation" column of the table in Appendix A for use of the Civic Theatres from September 1-December 31, 2019, in an aggregate amount of \$591,620; source of funding is the remaining balance in the 2019 Theatre Rental Grant Budget.
- B. THAT Council approve, in advance of the 2020 operating budget, 53 Theatre Rental Grants to the institutions listed in the Organization column of Appendix B in the Administrative Report dated April 30, 2019, entitled "Theatre Rental Grant Allocations Fall 2019 and Spring 2020", in the amounts set out beside their names in the "Jan 1– Aug 31, 2020 TRG Recommendation" column of the table in Appendix B for use of the Civic Theatres from January 1-August 31, 2020, in an aggregate amount of \$967,590; source of funding is the 2020 Theatre Rental Grants Budget.
- C. THAT, pursuant to Section 206 (1) (j) of the *Vancouver Charter*, Council deems any organization listed in Appendix A or Appendix B of the Administrative Report dated April 30, 2019, entitled "Theatre Rental Grant Allocations Fall 2019 and Spring 2020", that is not otherwise a charity registered with the Canada Revenue Agency to be contributing to the culture of Vancouver.

- D. THAT the General Manager of Arts, Culture and Community Services (GM of ACCS) is authorized to negotiate and execute agreements to disburse the grants described in the Administrative Report dated April 30, 2019, entitled "Theatre Rental Grant Allocations Fall 2019 and Spring 2020", on the terms and conditions generally set out below, and on such other terms and conditions as are satisfactory to the GM of ACCS and the City Solicitor.
- E. THAT no legal rights or obligations are created by the approval of A and B above unless and until the applicable theatre license agreement is complete and approved by the City in accordance with D above and executed and delivered by both the grant recipient and GM of ACCS (or their designate).

4. Contract Award for Consultant for Arbutus Greenway Character Zones Three and Eight April 29, 2019

Staff from Engineering Services responded to questions.

- A. THAT Council authorize City staff to negotiate to the satisfaction of the General Manager of Engineering Services, the Director of Legal Services, and the Chief Procurement Office, to enter into a contract with PWL Partnership Landscape Architects Inc., for the supply of consultant services for detailed design of the Arbutus Greenway Character Zones Three and Eight. The contract will be for a term of three (3) years. The award recommendation is for \$2,566,091.40, plus applicable taxes.
- B. THAT the General Manager of Engineering Services, the Director of Legal Services and the Chief Procurement Officer, be authorized to execute on behalf of the City the contract as outlined in A above.
- C. THAT no legal rights or obligations will be created by Council's adoption of A and B above unless and until such contract is executed by the authorized signatories of the City as set out in these recommendations.
