Constructing a multi-family building next to the Vancouver Hospice will have a negative impact on the hospice. Please take a moment to consider the needs of the dying and their families before you make a decision about the proposed development.

The noise that will occur during the construction period will disrupt the peaceful passing of many Vancouver citizens. Families and their loved ones who wish to spend their last days in hospice wold be faced with making the necessary arrangements to have their loved one die at home or in a hospital setting. This will add stress to an already stressful situation. They will be robbed of the assurance of comfort care and the ability to have a meaningful loving connection with their loved one and their family members.

My understanding is that the goal of this development is to provide affordable housing for families. The families that are most in need of affordable housing will not be able to access these units because of the high rental rates and purchase prices. If you want to build a community I don?t think building a multi-unit facility in a neighbourhood of single-family homes is the way to go about it. The supports a community needs include schools, grocery store, drug store and banks to name a few. Preferably within walking distance. Would you then allow other developers to go into the neighbourhood to build grocery stores, drug stores, banks, etc.? Have you considered any of this in your decision making? Do you think the members of the neighbourhood would be in favour of that kind of development?

Again I would ask you to look at the impact the construction of this development will have on the hospice and those who want to experience a peaceful ending.

You are working with people who exhibit those qualities in abundance at a time when people need it most. Can you yourself dig deep in return and find any of those same feelings for them or the people they serve?

Have any of you or your staff had the need of a Hospice? Have you experienced the empty Godless environment of VGH when medicine shows itself to be hypocritical ego driven commercial enterprise it truly is and can no longer provide the means to 'get better'?

People die. They die here, in this city. A compassionate City would provide a Hospice in every neighbourhood not just this one. Dear Members of Counsel,

I think it would be unconscionable for City Council to approve the development of townhouses at 4575 Granville Street located next to the Vancouver hospice.

This is not an appropriate location to approve a spot rezoning as the hospice is an integral part of our community and the 150 residents per year should be entitled to continue to live in a peaceful environment which was specifically located in a quiet residential area to support their needs. The families of the deceased need a quiet lane to say goodbye to their loved ones not a thoroughfare of traffic which would result in 29 additional cars using the lane to access parking under the townhouses.

Moreover, the intent of the developer has been made clear by his recent advertising of the **proposed townhouses for** <u>sale</u> which should make this development <u>ineligible</u> under the affordable housing initiative. In addition, even if these townhouses were to be rented one could never describe the rents as affordable.

I am writing you to oppose the approval for the rezoning of <u>4575 Granville Street</u>. Approval of this rezoning puts its direct neighbour, the Vancouver Hospice Society, at risk of permanently closing. Construction of a 21 unit building will destroy the peaceful, quiet, accessible and private features of the hospice. It will no longer be a desirable place to spend one's final days of life. It needs to be considered that the Vancouver Hospice Society provides 25% of the hospice beds in Vancouver. If the Vancouver Hospice Society has to close, where will those 25% go to pass away?

It is important for Vancouver to find more ways to increase the number of market rental properties but this is not an appropriate location to develop such a place. The Vancouver Hospice Society specifically selected this location and has become well established within the community.

Please consider our ageing population and value the finals days of an individual's life and refuse the rezoning application for <u>4575 Granville Street</u>.

1. Describe details (who, what, where, when, why):

Hello! I am writing about the risk posed to Vancouver Hospice Society, located on Granville Street, by proposed redevelopment of the site immediately adjacent to the hospice. I strongly object and do not support this proposed new development. The hospice had to carefully follow the applicable regulations in order to build its structure. Due to a strange set of circumstances the developer of the proposed development adjacent seemingly is able to seek erecting a massive, multi-level structure in a residential home neighbourhood. A developer should not be able to profit in this way in a residential neighbourhood, and especially not to the detriment of the hospice. The hospice serves a specialized medical purpose and there are few enough free standing hospice facilities in Vancouver as it is at present. There is no way dying individuals and their families can do through the process in a peaceful way

located beside a massive construction site. And should the hospice survive the construction, the extreme amplification to traffic in the street and alley way represent another negative outcome of the proposed development. The proposed development would also cast a massive 'shadow' on the hospice, out of keeping with other structures in the residential neighbourhood. Having neighbours with view corridors onto and into the hospice property is invasive and completely unnecessary.

Hospice is a location and also a philosophy. It is about supporting dying individuals and their family and friends during a most intimate and vulnerable process. No one should have to die 'on show' to the neighbours. Access to the hospice should not be impaired by an oversized-for the neighbourood structure and its occpants. This proposed development is completely inappropriate for the neighbourhood. The neighbourhood is not zoned for this purpose and nor should it be. And 'spot' rezoning is disingenuous allowing the developer to skirt the zoning requirement.

Thank you for reading my correspondence. Please vote against the proposed development.
