Dear Sir/Madam,

I am pleased to be able to provide written comments on the zoning change sought for 1462 Granville Street, as I will not be able to attend the public hearing on 9 July 2019. I support the zoning change as an appropriate use for this space.

The applicant seeks to amend the text of CD-1 (579) for 1462 Granville Street to allow "Manufacturing - Brewing or Distilling" as a permitted use for a small-scale craft distillery to occupy up to 650 sq. m of floor space on the ground level of the existing building (as part of the business in 3,440 sq ft at street level).

My understanding is that Longtable Distillery is the business seeking to locate in that site, and the applicant is seeking the zoning change to accommodate that use. As a current resident of the Beach District neighbourhood, I believe that their relocation will be a benefit to the community. Closing at 11 PM on weekday evenings seems appropriate, as this is a neighbourhood with working families.
