My name is Yianni Kerasiotis. My family owns and operates a popular Greek restaurant — essentially across the street from this proposed development. I'm writing with excitement about this prospect and in full support of the project.

As a business operator in the Fraser neighbourhood, I routinely notice the residential opportunities available here. Almost all rental properties are in poor condition or short supply. The lot where this development is being proposed currently consists of older homes that are not used to their full capacity — helping working professionals in need. Housing prices for a single family home in East Vancouver are sadly unattainable for the vast majority, leaving apartment living to be the most desirable option

Furthermore, from the perspective of a local business owner, adding a new build will be greatly beneficial to my family. We've felt firsthand the importance of foot traffic to drive our sales, and despite the desirable nature of our neighbourhood, we experience far less than we could. We've been able to sustain a healthy business from word of mouth, and we frequently receive a mix of compliments on the location with a simultaneous complaint of wishing that the street felt more alive.

I've also bore witness to how difficult the commute to work is on our staff, and I can think of several that would jump at the opportunity to apply to live in this proposed project.

To the Mayor and City Councillors:

My name is Frank Carr and I am Treasurer and Business Representative for the International Union of Operating Engineers Local 115. I write today in support of the above-noted rental project. IUOE Local 115 encourages the approval of this project and others like it. This project will be a source of job creation for our Union members (employed at Mainland Shoring and Deep Foundations). In addition, working people in Vancouver need more affordable rental accommodation.

In recent years, there has been a lot of construction activity in the Lower Mainland and our unionized signatory employers have had increasing difficulty sourcing staff to work on projects in Vancouver. A growing number of our members working in construction are faced with long commutes and heavy traffic. They would prefer to work in their communities closer to home.

It is well known that construction costs are higher in Vancouver than in other parts of the Lower Mainland. Because projects are often short staffed, construction timelines in Vancouver may be longer than usual, with high costs and delayed building schedules.

The city of Vancouver and the Lower Mainland badly need more affordable rental housing to accommodate working people so that they can work where they live. With more rental accommodation, our signatory unionized employers will be in a better position to employ unionized Building Trades workers, who in turn will support the businesses that comprise the local economy.
