I'd like to support the project proposed for 1535-1557 Grant Street in advance of your consideration at the September 12 public hearing.

I'll keep my comments brief – projects like this one are exactly what I'd like to see more of coming down the pipeline from the City's Planning Department. Rental housing, in this form, makes every bit of sense. From my own experiences, I understand the difficulty that can come from trying to find secured, quality rental housing. Projects like this one will help ease some of the pressure renters face and really make a difference for those looking to move to or stay in the Grandview Woodland community.

The Grant Street proposal is in a great location. I like that the proposal is for a property that is off a major road arterial – this isn't always the case with new developments and is something I'd like to see more of. Future residents of this building will be able to easily walk to pretty much anything they need – including rapid transit to get them even further.

I think its important to advocate for the delivery of more rental housing in our neighbourhoods and I think we need to make logical steps in the right direction in order to ease the housing market in Vancouver – in my view, this project will do just that.
