Dear Mayor Stewart and City Councillors,

My husband and I moved to River District in 2017, following an extensive search for quality and affordable rental housing. When we moved into our new home at River District, we were excited because the building had all the amenities that we wanted. However, although we love our new home at River District, the neighbourhood is seriously lacking in public amenities.

I understand that a plan was approved by Council in 2008 to build out new public amenities (parks, trails, day care, schools, etc) in River District, which would match the pace of development in the area. The community is continuing to grow and new housing is being approved but there does not seem to be a plan in place to deliver the promised public amenities. It has been brought to my attention that a new rezoning application is being considered at 3104-3130 Southeast Marine & 8420 Kerr Street. I am supportive of creating more housing, but to accommodate more growth in River District, we need our amenities to be delivered as soon as possible.

I hope that the City will start moving forward with the public amenity delivery for River District soon; there is huge demand here.
