A Special Meeting of the Council of the City of Vancouver was held on Thursday, March 19, 2020, at, 10:26 am in the Council Chamber, Third Floor, City Hall, for the purpose of declaring a state of local emergency, resolving to grant additional authority under the *Emergency Program Act* and amending an adopted motion to re-purpose community grants to better support the community's COVID-19 response. This Special Council meeting was convened by electronic means as authorized by Part 14 of the *Procedure By-law* and the *Vancouver Charter*.

2. Amendments to Community Services Grants to Allow Community Response to COVID-19 March 18, 2020

Sandra Singh, General Manager, Arts, Culture and Community Services, responded to questions by way of teleconference.

MOVED by Councillor De Genova SECONDED by Councillor Hardwick

- A. THAT Council approve the following amendments to Council's prior approval of 2020 Community Services and Other Social Grants (RTS No. 13579) and 2020 Renter Services Grants and Renter Service Update (RTS No. 13412) (the "Prior Resolution"):
 - With respect to all Social Services Agencies (as defined below), the General Manager of Arts, Culture and Community Services (or their designate) ("GM of ACCS") be authorized to accelerate the disbursement of the 2020 Social Grants (as defined below) to allow the community to respond to COVID-19 as quickly as necessary.
 - ii. With respect to all Social Services Agencies, the conditions of their respective grant agreements are now amended to allow the use of the grant for the following additional purposes subject to the following conditions:

- The grant must still be used for the benefit of the same members of the community that the original grant conditions required (the "Target Community").
- The applicable Social Service Agency may utilize the grant for any purpose that supports the Target Community in mitigating or preventing the transmission of COVID-19 or assisting any member of the Target Community who contracts COVID-19 (the "Re-Purpose").
- The Re-Purpose will be deemed to include any such costs as are reasonably necessary to protect the health of the employees and volunteers of the Social Service Agency in carrying out the Re-Purpose.
- All of the audit and records-keeping requirements of the grant agreement will continue to apply to all expenditures made in connection with the Re-Purpose.
- B. THAT, if Council approves A above, the GM of ACCS (or their designate) is authorized to issue all such amendments to the existing grant agreements for the 2020 Social Grants and issue all such other communications and execute any and all such documents as considered by the GM of ACCS reasonably necessary to implement the intent and effect of A above including all such clarifications and additional terms and conditions as considered by the GM of ACCS reasonably necessary in the circumstances.

CARRIED UNANIMOUSLY AND A BY THE REQUIRED MAJORITY (Vote No. 05713)
