Dear Mayor, City Council, Vancouver:

I am opposed to the Omnibus Bill you have coming up for review this evening and find it ill timed and an insult to the survival of the heritage and character homes in Vancouver. While Vancouver eagerly puts its 'Green' flag on many initiatives, the guidelines that allow the tear-down of liveable, cherishable heritage and character homes makes the 'Green' in your initiatives without grounds. The sheer waste of the resources that these homes represent, the increase in materials sent needlessly to the landfill is without logic and without soul.

My husband, Mr. Jeff Mercer and his family were the recent victims of a permit by the City for the tear down of the home his grandfather, Mr. Andrew Lamb Mercer, the first President of the BC Architectural Society, built for his family off Granville in Vancouver. This home was constructed to a level of quality and timelessness not to mention solidity that was meant to stand the test of time for hundreds of years. It was in fact recently demolished by permit and a 'look alike' new home (much larger) was built on the lot. The loss of now unattainable hardwoods that that home represented, stained glass, imported tiles, not to mention recently modernized updated kitchens and bathrooms and a suite made it a particularly poignant loss. The home of a major architect in Vancouver who designed St. Paul's, Breweries, many other public buildings as well as private homes was without regard for its importance, and was torn down.

I beg the City to forego this Omnibus Bill and to completely rethink how it views housing. You cannot say 'Green' and yet send to the landfill perfectly liveable homes that have stood the test of time and add to the character and liveability of Vancouver. At this time I see little valuation of

'heritage' in the City which is extremely sad, and the tremendous waste of precious building materials and fittings, not to mention difficult to dispose of materials needlessly sent to the landfill, leaves everyone wondering what Vancouver really stands for when it comes to housing stock.

Stop the needless destruction of character and heritage homes and buildings in Vancouver.

Once more Council is taking advantage of the pandemic to pass controversial measures such as this Regulation Redesign by=law. Under the limitations for public involvement and access to information these radical changes to the zoning of neighborhoods will pass without adequate scrutiny and input from stakeholders i.e. the residents of these neighborhoods. This particular measure will undermine further the retention of character houses which are integral to the identity of neighborhoods as well as being heritage buildings (designated or not) that are the few survivors of Vancouver's past. As well, these rezoning initiatives ignore the values and practices embodied in neighbourhood -based planning.
