In due course we believe it will be similarly greeted by Irish Canadians once this historic project gets more exposure. Thankfully the project can now proceed given that general agreement was reached between our Society and Vancouver Park Board staff in December 2020 on the design for the Monument at George Wainborn Park.

One of the names to be honoured will be that of former Mayor of Vancouver, Gerry McGeer whose family came from County Wicklow Ireland and who did much to help raise the funds needed to build City Hall at 12th and Cambie. A bust of Mr. McGeer is on permanent display outside the South door of City Hall.

Our Society understand that the City of Vancouver proposes to revise zoning of the land at Area 10B from transportation to residential.




