

BUSINESS LICENCE HEARING MINUTES

SEPTEMBER 29, 2020

A Business Licence Hearing of the Council of the City of Vancouver was held on Tuesday, September 29, 2019, at 9:30 am, in the Council Chamber, Third Floor, City Hall, to consider the recommendations by the Chief Licence Officer to refuse the reinstatement of the Business Licences for Short-Term Rental issued to the Licensee as set out in the Agenda and as recorded in the Minutes of this Business Licence Hearing. This Council meeting was convened by electronic means as authorized under Part 14 of the *Procedure By-law* and *Vancouver Charter* and the Minister of Public Safety and Solicitor General of the Province of British Columbia – *Emergency Program Act*, updated Ministerial Order No. M192.

lain Dixon, Assistant Director – Regulatory Litigation, Legal Department, was present on behalf of the City of Vancouver. Jan Koncewicz (the "Licencee"), was present and represented himself.

Mr. Dixon provided opening remarks, noting that the Licencee was not granted the Business License due to his previous offences for carrying on a business without holding a City Licence.

Koji Miyaji, Assistant Director of Community Standards, was present as witness on behalf of the City.

The Business Licence Hearing Panel asked questions to Mr. Miyaji.

Mr. Koncewicz provided opening statements and summarized his situation. The Panel asked questions to Mr. Koncewicz.

The Panel asked clarifying questions to Mr. Miyaji on City regulations relating to Short-Term Rental.

Mr. Dixon provided closing comments noting the Panel's role is to uphold, overturn or amend the decision of the Chief License Inspector in relation to status of the Business Licence of Mr. Koncewicz.

Mr. Koncewicz provided closing comments, noting that the strata council is the cause of the suspension of his Business Licence.
