I went to the Open House for this development and the feeling I got is that people living in the neighbourhood are overwhelmingly opposed to the massing of it. These people feel that if approved this rezoning is the start of a slippery slope towards their neighbourhood being overwhelmed and ultimately obliterated by over-tall buildings. If this proposal receives a "Yes" then the City will have no choice but to approve every future proposed building as tall or taller in the corridor. If the project were to be resubmitted at half the proposed height it would receive much more support from the people who live in and pay taxes in the neighbourhood. I have lived nearby at 11th and Wallace for 19 years, and I personally think the extra height being considered is totally out of synch with our neighbourhood. 10/27/2020	19:21	PH1 - 7. CD-1 REZONING: 3701 - 3743 West Broadway	Oppose	Dear Mayor and Council: Eight months into the pandemic, no vaccine... I am surprised that during a pandemic that could be around for some time, developers and their architects would not have shifted their approach to reflect societal changes. People are no longer comfortable living and working in extremely small spaces, rubbing shoulders in elevators, etc. This will not change. Given the spread of the pandemic, would you choose to live in 400 sq ft unit stacked up with 152 other units of a similar scale? And Mr. Gillespie, would you? Mr Stewart, Ms Degenova, Ms Carr, Ms Dominato, Ms Hardwick, Ms Swanson, Ms Bligh, Ms Boyle, Ms Kirby, Yung, Mr Fry and Mr Wiebe? This is the 3rd design to be presented for a structure at 3701-3743 W Broadway. I am familiar with all three proposals. The 3rd design is the worst - an oversized waffle dominating the street corner. It would be a blight to the city landscape and would not be a fit for any part of this neighbourhood or any other in the city. Six storys should be the maximum height for a building at Alma and Broadway. There is no regard to site lines, view corridors, shade and density. Already parking is at a premium, image driving west on Broadway with this edifice in your site lines. Infrastructure is another issue. I've attended two community sessions regarding this project, and spoken about my 14 years' experience living next to a dead-end back alley between Highbury and Alma. It is extremely busy, with loud back-up noise day and night. Now, with increased traffic in the area, trucks are having a much more difficult time backing onto Highbury. 3701-3743 W Broadway will have even more issues with a dead-end back alley feeding onto Alma St, which continues to grow as a traffic corridor. How has the ratio of 161 units, to 27 parking spots and 300+ bike spaces been substantiated? I am a cyclist, but I am well aware that not everyone is. The pandemic has resulted in people shying away from public transit and turning to private vehicles. Let's be realistic from a planning perspective, rather than assuming that everyone cycles 12 months a year. I should also mention, I am aware that developers are able to cut costs by reducing underground parking. This is just one of many projects being proposed for this city that should be re-examined at this crucial time of change. If we don't get 3701-3743 W Broadway right, I shudder to think how the Jericho Lands development will roll out. It's time for the City of Vancouver to review its tight relationships with developers and reconsider its approach to development. It's time for the City of Vancouver to think about the people who live here, and those who would like to live here. That should be the City's focus. I urge you Mr Mayor and Council take back control of the for sake of the people that already have chosen to call this home! To Mayor Stewart and City Councilors

West Kitsilano Residents Association (WKRA) **opposes** this rezoning.

There is strong opposition to this building in this location, as evidenced by the “No Tower at Alma & Broadway” petition that currently has approximately 3,000 signatures and counting.

The current rezoning application of 172 ft., 14 storeys ( equivalent to 17 storeys), and 5.3 FSR is not appropriate for this site. Instead, the previous 2015 rezoning application (that is now on hold) for 100% secured rental housing in a 6 storey building on this site should be reconsidered.

The proposal is largely premised on expectations that a multi-billion dollar Broadway Subway extension to UBC will actually be funded and built and that a station will be located adjacent to this location. Given the degree of uncertainty about the future (reductions in transit use, budget issues that may reduce public funding for subways, the shift to remote learning and working, changes in mobility technology and habits, and physical distancing practices) and implications of COVID-19, there is no assurance those expectations will be realized. The Subway requires very high ridership to make it viable. Due to the above changes, it is likely that an LRT network will be more feasible. An LRT network would also better meet the goal of connected neighbourhoods which is part of the provisional goals of the Vancouver Plan. Without a Subway station, this building becomes even more out of place. New directions should not be set in the scale of development without a more complete plan in place for the Alma/Broadway/Tenth intersections.

The proposal is being applied for through the MIRHPP program, which trades height and density bonusing for limited affordable housing benefit. This proposal would set a huge precedent for both West Point Grey and Kitsilano. While situated in West Point Grey, this precedent-setting development would affect future development in both neighbourhoods since it is located on their boundaries. It also sets a precedent for the forthcoming development in the Jericho Lands, which lie only one block to the west. The recent revised application has not addressed the main concerns as detailed below.

MIRHPP Policies includes requirements under section 3g. which must be met in order to get additional floor area and height, including urban design and policy requirements as follows:

#### Additional Considerations:

- Projects must consider and respect transitions to surrounding areas and homes.
- Neighbourhood context is an important consideration. In single family and duplex areas, projects in areas with existing precedents for higher buildings will be considered more appropriate locations for additional height and density.
- Policy direction in plan areas must be respected (e.g. Marpole, DTES, West End, Grandview-Woodland, Joyce Station Area, Cambie Corridor, Oakridge Transit Centre, Broadway).

The subject rezoning application is at odds with these considerations as follows:

- It is physically impossible to reasonably transition from the proposed height of 172 ft. and 5.3 FSR to the surrounding areas and homes.
- The subject rezoning application for a tower of 172 ft., 5.3 FSR has clearly failed to give adequate consideration to neighbourhood context.
- This application is in conflict with the West Pt. Grey Community Vision, which was approved by City Council in 2010.

We also are opposed because:

\*The proposed building does not meet the rules regarding height which is to be up to fourteen storeys in C2 areas at arterial intersections and up to 6 in RS areas which comprise part of this site.

\*It does not meet the rules regarding the arterial intersections because Broadway west of Alma is not an arterial.

\*It will severely overshadow the multi-family buildings to the north reducing the livability of these areas.

\*It is a massive and over bearing design that maximizes apparent bulk and dominates and overwhelms the street.

\* The financial incentives in the millions of dollars in addition to the huge density bonuses being given are not clearly justified by the housing benefit provided. This level of public subsidy requires more transparency regarding the financial benefits being given to the developer.

\*Its use of excessive amounts of concrete means that its carbon footprint will be very large. Wood structures increase environmental sustainability.

\*With 35% family housing, if even each family unit has one school age child, this one development will use up almost half of the available 2027 school capacity.

The City should not proceed with the current proposal since it does not conform to the MIRHPP requirements and should instead encourage the applicant to revisit its prior six-storey proposal. Recent precedents along West Broadway (e.g. the Parthenon building at Balaclava Street) for secured rental developments are a good model for a neighbourly scale and design, with appropriate setbacks for wide sidewalks and outdoor seating.

Please reject this rezoning.
