

- B. THAT Council approve an initial amount of \$500,000 to advance the objectives of the Special Enterprise Program.


The source of funding is the DTES Capital Grants funding:

- ii. \$150,000 for **capacity building** to businesses, non-profits and social enterprises;
- iii. \$200,000 to improve access to affordable spaces.

## **Legacy Business Study**

- A plan with business support tools for heritage businesses;
- Engage property owners and developers to develop affordable leases;
- Investigate the drivers of business closures and the needs of heritage businesses.

## **Activate DTES (Phase 1)**



- 55+ organizations are looking for suitable spaces;
- Businesses are looking for stable, longer-term leases of at least 5 years;
- Limited vacancy in existing industrial shared spaces point to the success in providing smaller scale, supportive spaces at more affordable rates, including shared service at professionally managed industrial co-working spaces.

## **Funding Allocation**



- \$150,000 for community-serving retail in Chinese Benevolent Society buildings, led by Strathcona Business Improvement Association;
- \$150,000 for business supports to procure consulting services from non-profit organizations to assist businesses, non-profits and social enterprises with capacity building;
- \$200,000 for affordable space activation to support potential tenants and cover the cost of tenant improvements.

### Total budget \$500,000
