#### **FINAL MOTION AS APPROVED**

A. THAT Council direct the City Solicitor to bring forward for enactment, a By-law (the "By-law") substantially in the form attached as Appendix "A" to the Report dated January 8, 2021, entitled "The Code of Conduct for Council Members and Advisory Board Members (BY-LAW NO.\_\_\_\_\_," with the following amendments:

# i. Section 2(f)

responsibility: a member must respect and comply with the Acts of the Parliament of Canada, the Legislature of British Columbia, including the *Vancouver Charter*, City by-laws, and applicable City policies, and avoid conduct that, reasonably, undermines, or has the potential to undermine, public confidence in City governance-except members may participate in peaceful civil disobedience; and;

## ii. Section 3.4(c)

ensure that all communications by, and on behalf of a member, including communications made via social media, are respectful and do not discriminate, harass, or defame any person, recognizing that free and open debate is guaranteed under the *Charter of Rights and Freedoms*;

#### iii. Section 4.6

A member must not instruct or direct any of the City's contractors, tenders, consultants or other service providers regarding City business; and

#### iv. Section 5.9(b)

provide advice and recommendations to a Council member, regarding their compliance or disclosure obligations under a provincial statute, such as the *Financial Disclosure Act*, or other such statute that imposes an express compliance or disclosure obligation on the Council Member due to their position as an elected official, where requested to do so by a Council Member.

- B. THAT Council direct the City Solicitor to bring forward for approval consequential amendments to the *Code of Conduct (Policy Number AE-028-01)* to exclude application to Council Members and Advisory Board Members upon enactment of the By-law.
- C. THAT Council direct the City Manager to conduct a selection process after enactment and that a recommended candidate for Integrity Commissioner be put forward for Council's consideration.
- D. THAT Council approve a budget of \$200,000 in 2021 from the \$2 million Council contingency, and direct staff to identify an ongoing funding source from deferral of investments, adjustment to service levels, or additional property tax increases to be considered as part of the 2022 annual budget process.
- E. THAT Council direct the Integrity Commissioner to review the provisions of the provincial *Members Conflict of Interest Act* to consider whether any provisions or features of the Act should be implemented in the by-law and that the Integrity Commissioner report back to Council, as part of their first annual report in 5.9(k) of the by-law, with any resulting recommendations to improve the by-law.

F. THAT Council delegate the appointment of the ad hoc Commissioner to the City Manager in all cases, in the absence of an appointment of an Integrity Commissioner.

# 2. Contract Award for General Excavated Materials Sorting, Loading and Hauling December 21, 2020

THAT the Committee recommend to Council

- A. THAT Council authorize staff to negotiate to the satisfaction of the General Manager of Engineering Services, City's Director of Legal Services, and the City's Chief Procurement Officer and enter into a contract with P. Sekhon Trucking Ltd. for general excavated materials sorting, loading and hauling for a term of three (3) years, with the option to extend for two (2) additional one (1) year terms, with an estimated contract value of \$4,664,790 plus applicable taxes over the initial 3-year term, to be funded through the annual operating budget for Engineering Services Kent Yard operation.
- B. THAT the Director of Legal Services, Chief Procurement Officer and General Manager of Engineering Services be authorized to execute on behalf of the City the contract contemplated by A above.
- C. THAT no legal rights or obligations will be created by Council's adoption of A and B above unless and until such contract is executed by the authorized signatories of the City as set out above.

# 3. Contract Award for PS20200434 – Provision of a Sewage and Rainwater Management Plan ("SRMP") for Vancouver December 11, 2020

THAT the Committee recommend to Council

- A. THAT Council authorize City staff to negotiate to the satisfaction of the General Manager of Engineering Services, the Director of Legal Services, and the Chief Procurement Officer a contract with Brown and Caldwell Consultants Canada Ltd., for the Provision of a Sewage and Rainwater Management Plan for Vancouver, for a term of approximately three and half (3.5) years with the option to extend at City's discretion, for another two (2) years with an estimated contract value of \$2,757,849, plus applicable taxes over the initial term, to be funded through the multiyear approved Capital Budget for the Clean Waters Plan (NEI-00009).
- B. THAT the Director of Legal Services, Chief Procurement Officer and General Manager of the Engineering Services be authorized to execute on behalf of the City the contract contemplated by A above.

C. THAT no legal rights or obligations will be created by Council's adoption of A and B above unless and until such contract is executed by the authorized signatories of the City as set out above.
