The Vancouver Chinatown Merchants Association writes this to support the rezoning proposal for 728-796 Main Street.

The Vancouver Chinatown Merchants Association has always advocated for economic revitalization in Chinatown through thoughtful re-development of underutilized lands and buildings. The idea is that these new developments could bring in new and more residents/customers to the neighbourhood while providing new opportunities to create more retail on Chinatown streets.

This re-zoning proposal offers 19 Social Hosing units and 75 market units of which more than 27 are appropriate for families. There are 6 Commercial Retail Units, also with a good mix of unit sizes and configurations. The VCMA feels that this diverse mix of unit types and sizes reflects the diversity residents and businesses that will sustain the economic health of Chinatown.

On Urban Design, the VCMA likes very much the strong 2 storey retail base that retains the traditional small storefront, fine grain expression at the street. We hope that the future development on the 800 block of Main Street will continue this urban form that is so characteristic of Chinatown.
