The staff, all the family counsellors and teachers from Fraserview neighbourhood house were lovely and kind and they provided coffee and conversation and after feeling isolated for so long it felt like I had found a community. My son and I continued to go every week and there we met many friends for him and myself. There were toys and a circle time and a fantastic way to spend a morning. This past year has been really girl at the start of the lockdown. During my maternity leave, my son (now 2), my daughter (10months) and I continue to go to an outdoor space where the family counsellors and teachers from Fraserlands family place have adapted to an undercover area to meet in the morning. We sing songs and they help support families like mine in what feels like a long Covid struggle. We would love a permanent indoor space close to home that we can use as a community centre to engage with our neighbours rain or shine. Our neighbourhood is diverse in socioeconomic and cultural backgrounds in a tapestry that just works. I am hoping the city of Vancouver can support our budding neighbourhood so we can continue to grow and support each other effectively. Over the past few years, a larger and larger percentage of our kindergarteners live below Marine Drive. This last year we had again maintained three Kindergarten classrooms, which reflects the number of young families that are choosing to live and raise their children south of Marine Drive. This is a section of Vancouver that young families are choosing to live in and I would like to strongly encourage the City to take steps to make the build of the community center a reality. Our families need a year-round indoor venue to exercise, congregate and make new connections. The demographic of this community has been changing over the past few years. When I arrived at Oppenheimer 3 years ago, there were only 16 language groups and a modest amount of English Language Learners. Now, we have 29 different language groups and a fairly high number of ELL students. The overall socio-economic level is decreasing. For the first time at Oppenheimer, we now have 25 students accessing the free VSB lunch program. Also, South Vancouver Neighbourhood House provides Food Bank supplies for 35 local families in need. Our families need a place where their children can attend extra-curricular programs and other supports, with the option to receive subsidy if there are financial barriers. A community center would offer them exactly that. During the pandemic, we have become increasingly aware of the needs of many families in our catchment. Presently, they do not have easy access to many basic services and supports. A community center would allow them a point of information and referral and outreach. Presently, south of Marine there are no indoor options for service providers to deliver workshops, provide information sessions or provide outreach opportunities. This has caused a substantial barrier for families to attend, especially for the young, non-walking babies. For example, these past two weeks the temperature was below zero resulting in us not attending since I didn't want to subject my son to the cold temperatures for too long. The Family Place has been providing excellent educational and developmental opportunities for my child, as well as social connection points that have helped me immensely to journey through motherhood with other families and to combat the loneliness that motherhood can sometimes hold. Dear Councillors and Mayor,

I am the principal of David Oppenheimer Elementary School, that presently educates the children of families living on the south slope, including the area south of Marine Drive and West of Kerr Street. Over the past few years, a larger and larger percentage of our kindergarteners live below Marine Drive. This last year we had again maintained three Kindergarten classrooms, which reflects the number of young families that are choosing to live and raise their children south of Marine Drive. This is a section of Vancouver that young families are choosing to live in and I would like to strongly encourage the City to take steps to make the build of the community center a reality. Our families need a year-round indoor venue to exercise, congregate and make new connections.

The demographic of this community has been changing over the past few years. When I arrived at Oppenheimer 3 years ago, there were only 16 language groups and a modest amount of English Language Learners. Now, we have 29 different language groups and a fairly high number of ELL students. The overall socio-economic level is decreasing. For the first time at Oppenheimer, we now have 25 students accessing the free VSB lunch program. Also, South Vancouver Neighbourhood House provides Food Bank supplies for 35 local families in need. Our families need a place where their children can attend extra-curricular programs and other supports, with the option to receive subsidy if there are financial barriers. A community center would offer them exactly that.

During the pandemic, we have become increasingly aware of the needs of many families in our catchment. Presently, they do not have easy access to many basic services and supports. A community center would allow them a point of information and referral and outreach. Presently, south of Marine there are no indoor options for service providers to deliver workshops, provide information sessions or provide outreach opportunities. This community is long overdue for a hub where this can take place. The school serves this function in many ways from September to June, but who helps and supports these families over July and August? Who provides an accessible continuum of care over Christmas holidays and March break? As a community we are calling on the City to deliver on its mandate: To create a great city of communities that cares about our people, our environment, and our opportunities to live, work, and prosper.

At the present moment South Vancouver represents 1/6 of the area of Vancouver. By looking at a map, it is clear that this area is long overdue for an indoor hub to build community for those of us living south of Marine Drive. Wesgroup is willing to commission the build and as a school we support the City taking steps to expedite the construction of the community center in East Fraserlands. It would be walkable for so many of our families and would be a safe place for our children to walk, bike or skateboard to on their own. It would create community and reduce our impact on the environment.

I am Julio Bello, the Executive Director for South Vancouver Family Place. I am writing in support of the building of a community center south of Marine.

The South Vancouver Family Place - Fraserlands Drop-In Program in the River District community has been in operation for over nine years since its inception in 2011. The thriving and fast-growing community (City of Vancouver community plans estimates that by 2030 the population will grow to over 14,000). We continue to need services, and we are the only resource for families with children in the River District Neighbourhood. We are grateful for the support from our partners City of Vancouver Wesgroup Development and Wesgroup Capital Savings, which allows us to provide this much-needed preventative resource. However, we are not enough for this diverse community.


As the community grows, we observe a greater need for families, seniors, and single young professionals to connect with others, share parenting experiences and participate in social and physical activities. In a society where extended family is typically far away, people find connection and support from others in their community. The Community Centre programs cultivate these connections between residents and create healthier individuals/families and build healthier communities.

I have provided a snapshot of participation at the Fraserlands Drop-In program.

- We offered 297 hours of service in 2019/2020.
- The program saw 408 individual families accessing the program with 3882 adult visits and 4290 children's visits.
- Out of these numbers, we saw 760 grandparents, 431 fathers, and 120 families who have been in Canada for less than five years.
- Also, in the Drop-In Program, we offered 42 hours of workshops for the families.

Also, we were able to keep the centre open for 197 days that translates to 297 hours of Drop-in program delivery. As stated before, this is not enough.


South Vancouver Family Place

It has been over a decade since the package of public amenities to support growth in our community was approved. We are thrilled about the City's commitment to have these amenities built by 2027.

My husband and I have lived in the East Fraser Lands neighbourhood now for more than 8 years and have

started our family here. Our two young boys play at the parks every day and we have met so many young families, giving us a real sense of community. However, the only walkable "community center", located at the visitors' centre by Romer's restaurant, is now closing and any other amenities are only accessible by car.

One year, our family had only one car to use, and I found it nearly impossible to get to the library or swimming pool with my three-year old son via public transit. It took around 30 to 40 minutes to reach these destinations, and often had us waiting on very busy streets. How sad for families who due to finances or disability, don't have a car to help them get around. I have watched a neighbor with disabilities trying to cross all four lanes of SE Marine Drive after taking the bus home from Metrotown, one of his few social activities. He couldn't make it to the other side before the traffic light turned green again. More than ever, we need parks and a community centre that people of all ages and abilities can access. Not only would more amenities benefit the diverse group of people who live here, but it would also help us do our part for the environment by helping us decrease our dependency on cars.

We really enjoy living in East Fraser Lands but find it can be isolating for individuals and families who cannot drive. My family is so pleased to hear that Wesgroup and the City are finally coming together on a plan and a timeline to deliver these amenities to our neighbourhood.

Re: River District Needs a Community Centre and Neighbourhood House Presence

Happy Holidays! We hope this letter finds you all in excellent health and spirits, as you gear up for what we hope will be a wonderful holiday season. It has been a challenging year, and we appreciate the efforts of City Council to meet the immense needs in the community. COVID was unexpected, and your leadership and quick action has been amazing.

That said, we are writing to advocate for the construction of a community centre in the River District / East Fraserlands area. As you know, neighbourhood houses are community-based organizations that work with local residents to strengthen their neighbourhoods to create meaningful engagement and meaningful change. South Vancouver Neighbourhood House (SVNH) has been in regular contact with City staff over the past few years around the needs of the community in the developing River District area. This stems from concerns brought forward from countless residents in the West and East Fraserlands area who have consistently been raising the issue of a lack of social spaces and amenities in their immediate neighbourhood. People lack places to connect, and much of what has been promised for years has yet to be delivered.

Moreover, SVNH has been conducting research and leading various asset mapping exercises to better understand the landscape across South Vancouver. We know that there has been historic underinvestment in physical infrastructure as well as social services in the neighbourhoods of Sunset, Victoria-Fraserview, and Killarney. Not only do these neighbourhoods consist of over 100,000¹ people – approximately one sixth of the overall population of Vancouver – the demographics include 80%² racialized persons, 56% newcomers, and a high density of English-language learners. South Vancouver has a high density of seniors (16% of the population), the largest household sizes (2.9 average vs. 2.2 in CoV overall), and the highest percentage of households with children at home (51% well above the CoV average of 30%) in Vancouver. I cannot think of an area more in need or deserving of spaces to participate in physical recreation, access programs for children, youth and seniors, and overall opportunities for community connection.

The **community needs the community centre** to be built in the River District area, and they need it soon. There is an influx of new residents moving to the neighbourhood and without adequate support, people are struggling with isolation, mental health challenges, and access to basic essentials. Transportation is a major concern in the East and West Fraserlands, and residents - especially young families and seniors with mobility challenges - cannot be expected to take unreliable transit or walk up a steep hill to access services. The City has a commitment to creating a Healthy City for All. This needs to include residents in the East and West Fraserlands areas.

In addition to a much-needed community centre, the Fraserlands area would greatly benefit from a neighbourhood house presence, which is not included in any of the current development plans. Neighbourhood Houses offer a unique approach to building social connection and strengthening community. Community centres cannot replace neighbourhood houses, nor vice versa. Both types of organizations are essential to create healthy communities, particularly when there is a large influx of new residents, and a need to build relationships between long-term residents and people new to a neighbourhood. Neighbourhood houses help to bridge gaps in language, culture, economic experience, and so much more. They are also designed to be low-barrier and to engage people who struggle to participate in mainstream services. While the burgeoning River District area falls within the catchment area of SVNH, without additional resources and space, SVNH is currently limited in the type of place-making that we can facilitate in this unique neighbourhood. We strongly feel that a separate neighbourhood house, or neighbourhood house annex, is essential for residents in the River District area to thrive in the decades ahead.

Thank you for your kind consideration. While we recognize that the City will have many priorities to deal with in 2021, we strongly advocate for the construction of a new community centre in the River District, and the addition of a neighbourhood house site, to be among your top priorities.

Once more, we appreciate all of your hard work throughout 2020, and wish you the very best over the holidays.

Re: East Fraserlands ODP

Please accept this letter, on behalf of the staff and Board members at South Vancouver Neighbourhood House, in strong support of the construction of a new community centre in the River District area of South Vancouver. As mentioned in the letter submitted to you dated December 23rd, we strongly feel that there is an immediate need for the construction of a community centre in the River District area. This is based on our understanding of the needs and the barriers of the diverse and growing community in the River District area. Social isolation is a significant concern, which would be alleviated by the development of a new community centre that is easy-toreach by local residents.

River District residents are cut off from the limited programs currently available in other parts of Victoria-Fraserview or Killarney, largely due to Marine Drive – effectively a highway – which cuts the River District off from other neighbourhoods in the area. Public transit is extremely limited, and geography also causes a challenge: there is a steep hill to climb to reach the nearest community centre, Champlain Heights Community Centre. The steep hill makes it nearly impossible for the people who would most benefit, including seniors, families with young children, and persons with disabilities, to traverse to the other side.

At present, 20/24 (or 83%) of the community centres across Vancouver are located north of 34th Avenue. The remaining community centres, Marpole Oakridge, Sunset, Killarney, and Champlain Heights, are difficult to access by River District residents. Other social amenities such as neighbourhood houses are also not equitably distributed across Vancouver. Of the eleven neighbourhood houses in the City, nine are north of 41st Avenue. There simply are not enough places for community members living across Marpole, Oakridge, Sunset, Victoria-Fraserview, and Killarney to connect. This includes the River District, which will only experience increased density over the next ten years. There is a need for the construction of a Community Centre in the River District with a neighbourhood house presence to ensure engagement and inclusion of community members with barriers to participation.
