Greetings Mayor Kennedy Stewart and City Council Members,

I am writing to express my strong objection to the proposal for the building project at 480 Broughton Street in Coal Harbour, and hereby I add my voice and reiterate the views of great opposition to this project expressed by the majority of people living in this neighbourhood.

Referring to my previous email on May 6th, I would like to once again highlight my objections by drawing your kind attention to the following points:

- A- Adverse impacts of unsustainable large development plans in areas with high <u>population</u> <u>density</u> such as Coal Harbour or other Downtown areas, particularly in the neighbourhoods with such limited road network, high traffic load and congestions.
- B- Questions and doubts about the precursor projects (i.e. **BC Hydro's use of Nelson Park** and **relocation of Annex School**) and suggestion of possible alternatives

While acknowledging the need for social housing for low-income families around the City and Metro Vancouver like the ones already built in Coal Harbour, I would like to highlight and expand the major points of objections in greater detail as follows:

- Currently the population density in Downtown including Coal Harbour is more than <u>3</u> <u>times</u> that of the City of Vancouver and more than <u>18 times</u> the population density in the Metro Vancouver area.
- 2- The wide gap between the population densities is the result of continuing rapid developments in the already densely populated areas leading to a population influx and subsequent additional housing demands. This has worsened the severity of housing problems and has led to soaring housing prices and rents and has diminished affordability.
- 3- The cycle of development and population surge specially in densely populated areas also challenges the urban infrastructure system and public services (e.g. transportation system, schooling, safety and security, health and medical services, utilities, electricity, water, and sewer systems, etc.).
- 4- Furthermore, building projects in the downtown area in general, particularly this large building on a small piece of land in Coal Harbour with a very limited road network and a cul-de-sac junction creates heavy traffic load and unbearable congestions which will have adverse impacts on the lives and health of the people in this area. Also, the increase in traffic load (917 vehicle trips/day) and heavy congestions will notably increase emissions and pollution and will completely violate the City's Climate Emergency Plan. More importantly, the construction of this large project in Coal Harbour will be detrimental and in total contrast to achieving the goals of the City's Transportation Plan, the success of which will hinge on developing neighbourhoods outside the downtown area.

- 5- In addition, further development and population increase in already densely populated areas can lead to other **social issues** (e.g. crime, homelessness, substance abuse, violence, etc.). Please note that downtown Vancouver including Coal Harbour is among the top five densely populated areas in North America; we do not want to Manhattanize this City. Do we?
- 6- One cannot deny that many daily ugly scenes in the City are to a large extent attributed to unsustainable urban development plans causing population influx with negative side effects, unknowingly inviting social problems together with obnoxious behaviours. No wonder why Vancouver, which was for several consecutive years the world's best city to live in, has lost its ranking and fallen off the chart altogether.
- 7- Therefore, contrary to all visions, mottos, and speeches frequently heard from authorities or decision-makers about *"sustainable development plans"*, focusing on construction projects in high-end densely populated areas, have and will lead to **uneven spatial planning**. This could, in turn, cause great heterogeneity in both public and private sector investments and thereby access to services across the city and metropolitan areas, with disproportionate impacts on the well-being of communities, while benefiting only a few developers who reap extra dollars at the expense of others.
- 8- While recognizing developers' works as an integral part of housing supply chain and job creation, we must focus on sustainable urban development and balanced spatial planning, while realizing the **limits to growth.**
- 9- Therefore limiting the construction projects in densely populated areas in general, and promoting construction in more affordable neighborhoods elsewhere, will lead to more incentives, housing market affordability, and better population distribution around the city. This can also be achieved by development/renovation/gentrification of other areas through Greenfield or Brownfield schemes while implementing plans for capacity building and empowerment of unprivileged population.

BC Hydro and VSB

Considering the BC Hydro's proposed project in Nelson Park is a precursor to relocation of Annex School and construction at 480 Broughton Street in Coal Harbour, I would like to raise my strong objections opposing this project based on the serious critical points highlighted below:

10-First and foremost, Coal Harbour residents in general, particularly those living in the immediate distance of the project site, were not informed about the Public Consultation meetings for building a substation in Nelson Park and the decision for the proposed waterfront construction project that would negatively and directly affect all of them. Such decisions were made without the participation and consultation of Coal Harbor residents.

- 11- If Coal Harbor residents were adequately informed, this project would have been rejected by a strong majority during 2018-2019. Having looked at the BC Hydro's online document the very slim approval was achieved without actual reference to most of the questions raised hereunder.
- 12-BC Hydro being a major stakeholder for use of Nelson Park conducted the consultation meeting. This is a major point of contention and conflict of interest. This should have been conducted by an independent body.
- 13-Based on the available online information, it is not clear at all if any <u>comprehensive</u> <u>feasibility and site selection study</u> was ever conducted together with the assessment of all tangible and intangible costs, as well as the impacts on the environment and community. This <u>comprehensive</u> study report should at least address the following issues /questions/options:
 - I. The structural condition of **Dal Grauer Substation** on Burrard Street and the possibility of strengthening and/or in situ refurbishment/renovation of this substation and any impeding factors to follow this path.
 - II. Has the possibility of purchasing alternative site(s) in the downtown been thoroughly investigated? Considering BC Hydro's financial status and its net income which rose to 705 Million Dollars last year alone, this option must be thoroughly investigated. BC Hydro tells us Nelson Park is cheaper.
 - III. The options for profit / revenue-sharing arrangements with private property owners, and/ or long-term rental of a property(ies) for new substation(s) also need to be examined and scrutinized.
 - IV. Splitting the substation and building 2 or 3 smaller ones. This option as a reference textbook guideline needs to be thoroughly investigated.
 - V. Even though St. Paul's Hospital seems to have been sold to a developer, the question still remains if it would still be possible to negotiate the use of a small footprint area there for an underground substation when the hospital is removed from this site.
 - VI. If it is deemed absolutely necessary to use Nelson Park for this purpose, a better alternative site would be the other side of the park bounded by Nelson, Thurlow, and Comox; i.e. 90 degrees rotation of the proposed concept and moving it to the east side of the park. This prevents destruction or relocation of the Annex School; only some trees need to be relocated perhaps to the other side of the park or elsewhere temporarily and moved back to a more suitable area in accordance with the Park Board decision.

- VII. If it is deemed absolutely necessary to relocate **Annex School**, then a vast available empty land at **Lord Roberts Elementary** can be used which has several advantages. This area with a footprint approximately measuring **60m by 50m** along Cardero and Pendrell Streets is (larger than the proposed site in Broughton St.) can be used for constructing either a conventional building or by more cost-effective **Modular** buildings technology which are seismically safe and currently in use in several places. This option at Lord Roberts Elementary, with the advantage of being closer, safer and fewer road crossings, will provide enough space to accommodate the VSB enrolment forecast and childcare facility and even more. Furthermore, reconstruction of the Annex in Nelson Park will provide additional space for more students.
- VIII. Another option for temporary relocation of the Annex School is a rental option during the construction of a substation in Nelson Park.

In the light of the above, I would like to kindly request you NOT TO APPROVE this project while recommending other fruitful and beneficial alternatives proposed by neighbourhood residents and garnering FULL COMMUNITY SUPPORT.
