On behalf of LandlordBC and our 3300 members, please accept this letter of support for the above-captioned rezoning application to create 109 secured purpose-built rental homes for the community. This project is an important step to help address the rental crisis in Vancouver by ensuring that families of all sizes have access to adequate housing in a highly liveable neighbourhood. Rental housing, and in particular secure purpose-built rental housing, will continue to be the best housing option for many of our residents, both current and future. We must therefore ensure that we continue to enable new rental housing to be built to meet demand.

The lack of new purpose-built rental supply and rising demand for rental in the past decade has contributed to Vancouver's rental housing crisis. To address the need, the City of Vancouver introduced important development incentives for purpose-built market rental housing including the Affordable Housing Choices Interim Rezoning Policy under which this application is being proposed. These incentives were some of the first of their kind in Canada and have resulted in a growing number of new units of rental being approved and the City deserves to be congratulated for its vision.

Even with the success of these incentive programs, the demand for new rental continues to outpace new supply, and the Vancouver continues to fall behind targets set in the City's 10-year Housing Vancouver Strategy for rental. Meeting these targets requires continued action on the part of the City and this Council to identify new locations for rental, like Dunbar, where this specific project is being proposed.

Dunbar is being hollowed-out housing-report/ as a neighbourhood and in desperate need of an influx of new residents to support the businesses in the community and return it to its vibrant past. The homes being proposed in this project, and the individuals and families who would live there, represent a huge opportunity to diversify and reinvigorate Dunbar. What a great opportunity for the City to encourage innovation and enable mid-rise affordable housing types in Dunbar! We are converting three single family homes to a housing typology that will provide 109 homes. We respectfully ask that you approve this project and thank you in advance.
