From the beginning of it's history with minimum build costs (as documented here: https://vancouver.ca/news-calendar/shaughnessy aspx), to the post war purge of rooming houses, to the implementation of heritage restrictions that use public government to create private exclusivity. While almost all "modern" land use regulations in Vancouver serve to implement class segregation, no area has been granted more of this state sponsored exclusivity, than Shaughnessy. The result of this is not, and never was felt "in" Shaughnessy, the result is felt outside of Shaughnessy, with increased pressure on rents, waiting lists, and prices, pushing people to leave, double up, or worse. On a city & regional level, the proposed building's effects will be small. But for the 24 households that will be able to live there, the effect will be large. But the largest effect will be felt outside of Shaughnessy, but the 24 other tenant households in Vancouver who won't be evicted to make room for the 24 households who will live here instead.
