AbCellera is playing a vital role in the national, international as well as local healthcare ecosystem by discovering new medicines based on antibodies. Most notably, the discovery of one of the first covid-19 neutralizing antibodies has resulted in a potent weapon against covid-19 which is now being used in many countries world-wide. Beyond covid-19 AbCellera is discovering new medicines for cancer and immunological disease. The ability to discover and manufacture these medicines in Canada is vital both to healthcare and to the economy. The creation of the lab facilities will enable the mission to continue at scale, leveraging the technologies that AbCellera has developed which are world leading. Without lab space, the capacity for discovery and development will be limited. The nature of the space and functions required is highly specialized - the development of new medicines cannot be undertaken in office buildings, for example. I know from personal experience that this sort of lab and research capacity is very limited in Vancouver, companies having to search many miles out of the city. Locations nearer the centre and close to transport hubs are more attractive to recruitment of the high calibre scientists and staff required. Having been involved in biotech research including company creation in the UK and US, the other positive benefit is that other local businesses prosper because of the increase in support functions to the staff and activities of the centres - the Cambridge Science Parks in the UK are a good example - estimation is that they boosted the local support economies by several billions over 20 years.
