For too long, the lack of affordable housing, especially near rapid transit has plagued communities in the Lower Mainland, especially in Vancouver. As an alumni of UBC, I hold particular concern for students and those of precarious financial circumstances. As a student, my options were either commute via transit for 1.5 hours while living at home, or pay exorbitant rents for something closer to campus. Needless to say, the cost of rent has only increased since I concluded my studies at UBC. More supply of housing is urgently required to alleviate the housing shortfall. While studying, I also worked in Vancouver by False Creek. Far too many of my co-workers lived way out in the suburbs. They could not afford housing, and faced long commutes home in the late evening when our shifts ended. These unheard voices, who would love to live in Vancouver because they work and study there, decrease to be kept front of mind as these applications are heard before council. Mixed used buildings should also the norm rather than the exception. While this proposal is taller than most, it is necessary due to the circumstances we find ourselves in. Failure to dramatically address the sparsity in housing we currently face will only require even greater and more dramatic density in the future. Council must act now to forestall the need for even more dramatic, and potentially disruptive density in the future. There is a joy to mixed use in the freedom it provides to the community and residents. Being able to walk down stairs, or down the street to pick up essentials you forget or run out of. Being able to have transit you can utilize without having to plan or worry about. The stress that is alleviated when a missed bus does not lead to a stern talking by your supervisor because the bus only comes every 30 minutes.
