The mandate of the Renters Advisory Committee is to advise Vancouver City Council on strategic City of Vancouver priorities relating to renters, to monitor and respond to the impacts of provincial and federal legislation affecting tenants and to advise Council on enhancing access and inclusion for renters in developing City policy and civic life. Our advice as a committee is to support this proposal. The scope of the project is in line with the proposed Broadway Plan, it is in line with the city's stated objectives of being one of the world's greenest cities, and it is in line with addressing the multiple generational crises facing our city.

This proposal takes a small step in the right direction to provide market and affordable housing, mixed use, and direct access to active transportation options and rapid transit.
