- SUBJECT: April 28th Special Meeting of Council Outline and Details Understanding Concerns related to Public Safety and Violent Crime Citywide

On March 30, 2022 Vancouver City Council passed a <u>motion</u>, calling for a Special Council meeting at which Council could hear from delegations representing residents, businesses and communities, in order to understand concerns related to public safety and violent crime citywide.



Meeting purpose

The focus of the meeting is to hear perspectives, concerns and recommendations relating to public safety and violent crime in the City of Vancouver. A number of agencies have been invited to attend this meeting along with City Staff as specified in the motion, and present to City Council for up to five minutes concerning their organisation's current/contemplated strategies and actions related to addressing public safety and violent crime in Vancouver.

The public will also be heard. Members of the public are encouraged to share their concerns on public safety and violent crime citywide directly at this meeting by either registering to speak or submitting their comments online. The public may also listen and stream the live proceedings online.

This meeting is being convened as a Special Council Meeting under section 14.5 of the *Procedure By-law*, and will be chaired by the Mayor. No decisions of Council are required at this meeting.

Next steps

Per the Council motion cited above, staff will work with the Vancouver Police Department to report back to Council by June 2022 with an action plan to address public safety concerns and issues, and will at a later date report back to Council with the scope for a "Vancouver Community Safety and Well-Being Strategy," which would seek to understand and address the root causes of inequity so that all residents have access to the people, places, programs, services and supports necessary for their safety and well-being.
