

- A. THAT Council approve the *Making Strides: Vancouver's Childcare Strategy*, including the vision, guiding principles, values, policy directions, policy goals and Early Actions;
- B. THAT Council direct staff to report back by Q2 2023 on the status of Strategy implementation through Early Actions, and to seek Council approval of an initial Four-Year Action Plan, encompassing targets and goals, resource needs, policy changes, strategic partnerships, alignment with senior governments, and monitoring;
- C. THAT Council approve the framework for a *Community Childcare Expansion Program* (CCEP) to support the creation of new childcare spaces led by non-profit organizations and public partners;
- D. THAT Council request the Mayor write a letter to the Minister of Education and Child Care to acknowledge her new responsibilities within the newly expanded Ministry, and to improve collaboration and partnership opportunities between the Province and the City of Vancouver in order to create new childcare spaces;

FURTHER THAT the Mayor request a meeting between the Ministry of Education and Child Care and the City of Vancouver as soon as possible to discuss ways to advance policy, planning and delivery of childcare at the City of Vancouver and all its partners, including the Vancouver Board of Education (VBE).





The Federal and B.C. governments are developing a universal childcare system by:

- Signing a new Canada-British Columbia Canada-Wide Early Learning and Childcare Agreement 2021-2026 and renewing 2017 bilateral agreements
 - Including a \$30B new financial commitment, Canada-wide
- Committing to increase the number of \$10-a-day spaces in B.C. from 2,500 in 2018 to 6,500 in 2021, with a goal of 12,500 by December 2022.
- Creating a new **B.C. Ministry of Education and Child Care**
- Conducting broad public engagement and updating plans and strategies



Childcare is an essential service and primarily a provincial responsibility.

But less than half of families seeking licensed childcare in Vancouver today can find a full time space.

Shared Tasks Ahead

Plan for, invest in, construct and secure licensed facilities for equitable access

Mobilize to support senior governments to land child care funding in Vancouver

- Build and support capacity &
- networks for a functioning, universal childcare system



Making Strides will create a platform for the City that will:

- Establish clear City directions, roles & responsibilities
- Address the lack of childcare space supply
- Build equity into the City's approach to childcare
- Help prepare Vancouver for the future of childcare

Making Strides: Scope



In Scope:

- Space creation land use regulation and the municipal toolkit
- Sectoral coordination and capacity building
- Advocacy to senior governments
- Advancing early learning and care for Urban Indigenous communities in Vancouver

Out of Scope:

- Direct operational funding or broader gaps in the childcare system (*e.g.* ECE wages, labour shortages, parent fees)
- Non-licensed, nonregulated childcare





Making Strides: Vancouver's Childcare Strategy Proposed Policy Framework





1. Policy Framework (10 years)

Vision, values, principles, directions, and goals

2. Early Actions (>1 year)

- 5 Early Actions, no additional resources required
 - Community Childcare Expansion Program
 Framework (capital grant program)

3. Future Strategy Implementation

- Staff to report back in 2023 with a fully scoped 4-Year Action Plan, including resource requests
 - Financial Strategy with targets

Making Strides: Proposed Vision Statements





10-year Vision:

Significantly more families have equitable access to essential \$10aDay childcare services that meet their needs within a more family-friendly city.



30-year Vision:

All Vancouver families can access affordable, quality and inclusive childcare to work, learn, or meet other daily needs as part of a universal, public system.

Making Strides: Proposed Core Principles





- Early Learning and Childcare is a right, an essential service and a foundational City priority
- The City supports senior governments in moving to a universal \$10-a-day system
- The City integrates childcare planning and implementation across processes and departments, and streamlines systems
