### RECOMMENDATION

- A. THAT Council approve the Heritage Conservation Grant Program Annual Report 2021/22, attached as Appendix A.
- B. THAT Council approve payment of a grant to the Vancouver Heritage Foundation in the amount of \$300,000 for the implementation of the fourth year of the Heritage Conservation Grant Program (2022/23), source of funding 2022 Capital Budget.

Approval of Recommendations A and B constitutes grants and therefore requires an affirmative vote of at least 2/3 of all of Council members pursuant to Section 206(1) of the Vancouver Charter.

## REPORT SUMMARY

This report seeks Council approval of the Vancouver Heritage Foundation ("VHF") 2021/22 Heritage Conservation Grant Annual Report as required by the agreement between VHF and the City (the "Grant Agreement"). In addition, this report seeks approval of the payment of a grant of \$300,000 to VHF for the implementation of the fourth (and last) year of the Heritage Conservation Grant Program (the "Program") under the current Grant Agreement.

### COUNCIL AUTHORITY/PREVIOUS DECISIONS

On March 13, 2019, Vancouver City Council approved the Heritage Incentive Program (RTS 12903) to implement the Program. There is \$1.2 million allocated in the 2019 – 2022 Capital Plan to support grants approved through the Program.

An annual grant of \$300,000 for the fourth year of the Program was approved as part of the 2022 Capital Budget.

The City Manager recommends approval of the foregoing.

## **REPORT**

## Background/Context

The 2019-2022 Capital Plan approved a four-year \$1.2M grant to VHF to fund the Heritage Conservation Grant Program. This Program supports a wide variety of exterior conservation project types for buildings and sites on the Vancouver Heritage Register, by providing matching grants of up to 50%. Eligible projects range from developing a conservation plan to the restoration of historic elements and conservation of the structure and exterior of a building. Projects are located citywide and represent a diverse spectrum of buildings and sites and ownership types.

The program emphasizes best practices in heritage conservation, including planning and implementation. Through the program, VHF provides guidance to owners, building stewards, and professionals to achieve a high standard of conservation. Support of this kind is unique to Vancouver and is enabling a high standard of conservation that would otherwise be inaccessible for most site stewards and owners. High quality support for heritage places ensures the continued vitality and viability of heritage sites and neighbourhoods.

### Strategic Analysis

## Program Marketing

With many of the 2,200+ buildings and sites on the Vancouver Heritage Register eligible for the Program, target audiences for communications include homeowners and building owners, long-term tenants such as non-profit societies, and heritage and construction professionals. Over the course of the Program, details have been communicated through the following methods:

- Direct mail campaigns addressed to properties on the Vancouver Heritage Register
- Grant information sessions offered twice annually (September and February)


## Year 3 (2021/2022) - Results

The Heritage Conservation Grant Program had a very successful third year, allocating all available funds and leveraging private investment in Vancouver's historic buildings and sites.

The 2021-22 (Year Three) grants are supporting projects in 15 different neighbourhoods, with the highest numbers in Mount Pleasant, Chinatown, Kitsilano, Strathcona, Downtown Eastside and Grandview-Woodlands.



Locations of Projects, 2021-22: Heritage Conservation Grant Program

The maximum grant available is \$25,000 for a site with Heritage Designation that is owned/managed by a non-profit society. Sites in private ownership, with or without Heritage Designation, can qualify for a maximum grant of between \$7,500 and \$10,000 for conservation projects and a maximum grant of \$2,000 - \$3,000 for planning projects.

In its third year, this program supports local jobs and skilled work, investing \$1,472,625 into the local economy, 75% of which is from private investment by owners and building stewards.

The Program offers a unique and efficient financial incentive to motivate and enable small and medium sized conservation projects that help to ensure the long-term survival and appreciation of a wide range of heritage places across the city. Restored and rehabilitated heritage buildings are treasured places that can provide a sense of continuity, community, and identity. Seeing familiar places restored and cared for can help lift spirits and encourage optimism for the future.

## Year 4 (2022/2023)

With continued funding support, VHF will open the fourth year of the Program for applications in August, 2022 with a close date in October. Funded projects will get underway starting in early 2023.

The fourth year of the Program will continue the benefits, including:

- Encouraging heritage retention, conservation, and stewardship.
- Leveraging private investment in Vancouver's heritage buildings and sites.
- Providing education on best practices through guidance to achieve a high standard of conservation, including local knowledge and skill development among owners and construction professionals.

This Program also provides important incentives and support for additions to the Heritage Register through the Vancouver Heritage Program process, including achieving greater inclusion of places that further reflect the diverse local history and cultural heritage of Vancouver. It is aligned with the Vancouver Heritage Program goals to recognize diversity of heritage values, enhance heritage management tools, link heritage to other City goals, and to promote public awareness, engagement, and support.

For the fourth year of the Program, VHF proposes to expand eligibility to sites of Indigenous cultural significance by removing the requirement for a building or site to be listed on the Vancouver Heritage Register. This change to the Program guidelines will further reconciliation goals and would advance efforts to formally recognize Indigenous Histories and Cultural Heritage.

The proposed Program improvements would not impact the previously approved budget of \$300,000 annually.

## **Funding Summary**

The available funds for the third year of the Program was \$300,000. Of this, \$230,000 was available for grants and \$70,000 was allocated to administration and communications.

Funds that are not claimed by third year grantees who withdraw will be added to the funds for grants to be allocated in the fourth year of the Program. The funds carried forward from year two were \$52,260.

The projects awarded in the third year of the Program are outlined in Appendix B. Of the \$282,260 available in the third year of the Program for project grants, \$7,462 has already been disbursed. This includes disbursements to non-profits, which may request access to up to 50% of a grant at the time of initial project start up. It also includes disbursements for one completed project.

The status of projects that have completed or are still in progress from the first and second years of the program is provided in Appendix C.

### Administration costs: July 2021 – June 2022

VHF staff and office costs include grant program management, supervision, equipment, expenses, and administrative support. Communications costs include copy writing, as well as design, printing, and mailing of promotional materials.

The available annual administrative funds of \$70,000 provided by the City of Vancouver for administration and communication of the program in 2021-22 is fully accounted for and the amount exceeding \$70,000 (for year three this amount is \$6,000) is provided by VHF from fundraising revenue.

In addition, an estimated 80 volunteer hours were committed in year three by the Granting Committee members with an estimated value of over \$10,000.

### **Financial**

In the first year of the Program (2019/2020), funds totalling \$300,000 were allocated in accordance with the Grant Agreement, including \$230,000 for grant projects and \$70,000 for administrative costs.

In the second year of the Program (2020/2021), grant funds available for distribution totalled \$371,772. This included \$50,772 carried over from year one grants for projects that did not proceed, as well as an additional private donation of \$21,000 for True Colours projects. Of the total funding available, \$70,000 was spent on administrative costs as per the Grant Agreement and \$301,772 was committed to 50 grant projects. Of those funds committed, grants totalling \$294,212 were committed to the 49 projects that were proceeding. Any unallocated funds from year two were carried over for distribution in year three.

In the third year of the Program (2021/2022), grant funds totalled \$352,260.20, including \$52,260 that was re-allocated from year two projects that did not proceed. Of that, \$70,000 was spent on administrative costs and \$282,260 has been committed to year three grant projects.

This report recommends a grant of \$300,000 to VHF for the implementation of the fourth year of the Program as per the grant disbursement schedule in the Grant Agreement. The source of funds for the grant is the 2022 Capital Budget.

## Legal

On June 6, 2019, Council approved the current Grant Agreement (2019-2022).

### CONCLUSION

The Heritage Conservation Grant Program offers a unique and efficient financial incentive to motivate and enable small and medium sized conservation projects that help to ensure the long-

term survival and appreciation of a wide range of heritage places across the city. It continues to evolve by improving accessibility and diversity.

Staff recommend the approval of the fourth year grant to continue implementation of Council approved Vancouver Heritage Program through a partnership with Vancouver Heritage Foundation.

# HERITAGE CONSERVATION GRANTS PROGRAM - ANNUAL REPORT

The Heritage Conservation Grants Program was approved by Council on March 13, 2019, as part of the Heritage Incentive Program with a commitment of \$1.2 million over four years.

Vancouver Heritage Foundation (VHF) launched the grant program in September 2019 with the first intake of participants in October 2019. The program is now in the third year of the four-year agreement.

The Heritage Conservation Grants Program supports a wide variety of small and medium conservation projects for sites on the Vancouver Heritage Register that do not qualify for larger City programs. Eligible projects include the development of a conservation plan, the restoration of historic elements, and the conservation of the structure and exterior of a range of sites with diverse ownership types.

The program emphasizes best practices in heritage conservation including planning and implementation. Through the program, VHF provides guidance to owners, building stewards, and professionals to achieve a high standard of conservation. Support of this kind is unique in Vancouver and is enabling a high standard of conservation that would otherwise be inaccessible for most site stewards and owners. High quality support for heritage places ensures the continued vitality and viability of heritage sites and neighbourhoods.

### PROGRAM IMPLEMENTATION

VHF has continuously improved the program since its inception with feedback gathered during the first and second years. There are two intakes for each round, with the first intake in October and a second happening the following February.

Applications are reviewed by a Grants Committee composed of members with extensive heritage expertise who provide recommendations on grant amounts and proposed projects. The Committee's recommendations are then submitted to the VHF Board of Directors for review and confirmation. Grant decisions are communicated to applicants and agreements are signed that set out the conditions of the grant, including the requirement to obtain any necessary permits and hold proper insurance for the proposed work.

Each grantee has eleven months to complete the work, with the potential for extension in extenuating circumstances. Grant amounts are paid out upon satisfactory completion of the work, except for non-profit society applicants who can request 50% of their grant at the start of the project.



### 2020-21: YEAR TWO SUMMARY

In the second year of the program, VHF offered 50 grants and of those awarded, 39 projects have successfully completed. Two successful applicants pulled out of the program over the course of the year as one applicant decided to sell the site, while the other felt the support was too little to proceed with the project. 9 projects are ongoing and have been granted extensions to address difficulties in securing contractors during the COVID-19 pandemic. At the time of writing, \$215,399 has been disbursed to conservation projects from the two intakes of Year Two of the program. A further \$65,298 is anticipated to be disbursed to the remaining projects from Year Two.

It is important to note that there have been major improvements in the completion rate as compared to the first year of the program. Year One saw 15 withdrawals from a total of 45 approved projects, which was most certainly due to the strain of the pandemic and a lack of contractor availability. VHF absorbed the unused portion of funding from Year One into later intakes and extended the level of support to successful projects. Several of the projects that withdrew in Year One re-applied and were successful in Year Two. Successful projects in the second year of the program included masonry restoration, painting in historic colours, stained glass repair, porch restoration, roofing, and siding repairs.

## 2021-22: YEAR THREE SUMMARY

Projects from the two intakes of Year Three are underway, with grants supporting 37 projects at 36 sites across the city. In this intake, demand for funding exceeded the available funds by over 50%. The grants proceeding as of April 2022 will provide \$282,260 and leverage a further \$631,828 in private investment and other funding for Vancouver's heritage buildings.

This program is contributing to Vancouver's pandemic recovery by supporting local jobs and skilled work. \$1,472,625 has been invested into the local economy through this program so far, 75% of which is coming from private investment by owners and building stewards. The total investment in local heritage places resulting from this program from 2019-2022 is anticipated to be \$2,713,950, with a financial contribution from the City of only \$900,000 (\$690,000 in grants, \$210,000 in administration).



### YEAR THREE RESULTS

The Heritage Conservation Grants Program had a very successful third year, allocating all available funds to provide meaningful support to projects, while leveraging private investment in Vancouver's historic buildings and sites.

\$300,000 is committed by the City of Vancouver for each year of the program. Of this, \$230,000 is available for grants and up to \$70,000 is allocated to VHF for administration and communications.

If a grantee withdraws from the program, the funds are added to the following intake. An additional \$52,260.20 was available from Year Two and was added to the available funds for Year Three. The total available to grant in year three was \$282,260.20.



## LOOKING FORWARD - YEAR FOUR

Continued investment in heritage conservation through this program in 2022-23 will further contribute to social and economic recovery. The program will continue to leverage private investment to assist in retaining and improving housing, rental accommodation, and community spaces; will encourage sustainable reuse of existing buildings; and will help sustain the local economy through the creation of skilled jobs.

The release of the fourth year of funding of \$300,000 is requested so that this program can be ready to support Year Four projects in 2022-23. A new application period will open as soon as funding is approved, with a close date in October 2022 for the first intake.

The fourth year of the program will continue the benefits including:

- Encouraging heritage retention, conservation, and stewardship.
- Leveraging private investment in Vancouver's heritage buildings and sites.
- Providing education to owners and construction professionals on best practice in heritage, including the *Standards and Guidelines for the Conservation of Historic Places in Canada*



### PROGRAM RENEWAL 2023-2026

The Heritage Conservation Grants Program offers a unique and efficient financial incentive to motivate and enable small and medium sized conservation projects that help to ensure the long-term survival and appreciation of a wide range of heritage places across the city. Restored and rehabilitated heritage buildings are treasured places that can provide a sense of continuity, community, and identity. Seeing familiar places restored and cared for can help lift spirits and encourage optimism for the future.

The program is regularly over-subscribed with minimal advertising. As such, we anticipate continued strong demand for this program from site owners and stewards. Every supported project ensures our city's heritage stock is maintained over the long term and each project serves as an example that can inspire others to follow suit and invest in their heritage asset.

A renewal of the program funding for a further four years (2023-2026) would increase and sustain the program's positive impact in the community. Continued investment in the program would also contribute to developing local skilled trades in heritage. A minimal contribution from the city would continue to leverage millions of dollars in investment into the local economy.

# **Expanded Eligibility**

For a renewed program, VHF proposes to expand eligibility to sites of Indigenous significance that are not currently on the Vancouver Heritage Register. This change to the guidelines would further reconciliation goals and would advance efforts to formally recognize Indigenous heritage sites. Ideally, these sites would also have a future home on the Heritage Register, which is underrepresented by Indigenous sites.

This expansion of the program would provide an important incentive and support for additions to the Heritage Register through the Heritage Action Plan and Vancouver Plan processes. This furthers the City's goals to achieve greater inclusion of places that further reflect the diverse local history and cultural heritage of Vancouver. It is aligned with the Vancouver Heritage Program goals (approved March 10, 2020) to recognize a diversity of heritage values, enhance heritage management tools, link heritage to other City goals, and to promote public awareness, engagement, and support.
